MINUTES JOINT CONFERENCE COMMITTEE MEETING FOR LAGUNA HONDA HOSPITAL AND REHABILITATION CENTER March 9, 2021, 4:00 p.m. Remote Meeting via Webex Event

1. CALL TO ORDER

The meeting was called to order at 4:03pm.

2. APPROVAL OF MINUTES FOR MEETING OF FEBRUARY 9, 2021

Action Taken: The Committee unanimously approved the February 9, 2021 minutes.

3. GENERAL PUBLIC COMMENT:

There was no general public comment.

4. CHIEF EXECUTIVE OFFICER REPORT

Michael T. Phillips, Chief Executive Officer, presented the item.

Commissioner Comments:

Commissioner Guillermo congratulated LHH leaders and staff for all the good work to keep residents safe.

Commissioner Chow asked how the LHH kitchen staff ensures food is as warm as it should be in the temporary kitchen. Mr. Grimes stated that staff uses the same procedures of taking the temperature of food frequently. He added that plans for distributing food from the temporary kitchen are still being worked out. Commissioner Chow requested an update at the next LHH JCC meeting.

Commissioner Green asked for analysis of contributing factors in the decreases in COVID-19 cases at LHH this month. Mr. Phillips stated that the vaccine has been effective in substantially reducing staff and

resident cases. He noted that no COVID-19 related protocols have changed in the last month. Dr. Hathaway stated that staff and residents are tested twice each week.

Commissioner Green noted that the Center for Disease Control recommends that small groups of vaccinated people can be together unmasked; she asked if this recommendation will change mask-wearing levels for LHH residents. Mr. Phillips stated that LHH still requires masking of all residents and noted that residents have been compliant with this protocol.

Commissioner Guillermo noted that 280 LHH staff have not been vaccinated and asked if any of these include frontline staff. She also asked for more information on reasons given by staff for not being vaccinated. Dr. Fouts stated that reasons for not getting vaccinated yet include hesitancy with vaccines in general and some staff are currently pregnant. Mr. Phillips stated he is hopeful that more LHH staff will accept the vaccine.

Nawzaneen Talai, Chief Quality Officer, presented the item.

Commissioner Comments:

Commissioner Guillermo thanked Ms. Talai for the report.

6. PRESENTATION: DRUG REGIMENT REVIEW

Michelle Fouts, Director of Pharmacy, presented the item.

Commissioner Comments:

Commissioner Chow asked if EPIC is helpful in monitoring medication distribution. Dr. Fouts stated that EPIC has been very helpful and added that the huge amount of data in the system aides all clinical staff.

7. PRESENTATION: COVID VACCINE DISTRIBUTION

Wilmie Hathaway, Chief Medical Officer; Michelle Fouts, Director of Pharmacy, presented the item.

Commissioner Comments:

Commissioner Green noted that the S5 neighborhood had a low level of vaccine distribution compared to other neighborhoods. Mr. Phillips stated that this neighborhood is the COVID-19 unit and has a smaller number of residents.

Commissioner Guillermo stated that she looks forward to seeing more LHH staff and residents vaccinated. Mr. Phillips noted that some family members of LHH residents have concerns about their loved ones getting the vaccine.
