#### COVID 19 Island-wide Services Coordination

• COVID Testing has been extended through the end of August 2021. Testing continues in the parking lot at the Family Services Space.

#### Food Pantry

We continue to operate the weekly Food Pantry on Tuesdays with an average of 120 households accessing the pantry. One TI continues to provide supplemental cleaning supplies monthly to all Island residents at the food pantry.

#### • Treasure Island Resource Line

The Resource line continues to operate and will remain operational indefinitely. The Resource Line is also being used by residents to sign up for meal kits and gift cards through the Nourish TI project.

#### • SFUSD Kids Meal Program

The program is suspended through the summer. The YMCA is in conversation with the SFUSD to begin operating the program again in the Fall.

#### • Economic Self Sufficiency Program

Financial Services workshops began in July are have been well attended. Workshops focus on banking and saving for retirement.

#### • Construction Training Program

The 10<sup>th</sup> cohort of the Construction Training Program began on July 12, 2021 and there are 16 participants in the training program. Graduation is September 2, 2021. More information to come!

#### • Community Engagement

#### Outreach & Social Media

Community engagement continues through social media posts and socially distanced events.

#### • Community Workshops

Workshops will resume in September 2021 with Employment Readiness Workshops geared towards youth and adults, Emergency Prep workshops and Financial Education workshops being held through the end of the calendar year.

#### Holiday Celebrations & Events

The National Night Out/Backpack giveaway event was held on August 3, 2021. The event was well attended with over 150 residents plus vendors, nonprofit staff, resident groups, the Villages and TIDA staff. All enjoyed the evening with pizza, hot dogs and the DJ. Back packs were given out to children and the SFPD and SFFD engaged the community through handing out stickers, fire hats and information. The Villages, YMCA, SFPD, Residents Supporting Community and Job Corp all provided raffle prizes including bikes, emergency prep backpacks, gift cards and SF Giants gear. Thank you to all who helped to make the TI National Night Out a big success!

#### • Nourish Treasure Island

The One TI Nourish TI project is in full swing with free food being offered to island residents 5 days per week. An average of 200 residents are requesting meals from both restaurants and the food trucks on Saturdays. Meal kits are being distributed as requested and gift card distribution will begin in September. Adjustments are being made to the project as needed to ensure seamless operation.

#### **Back Up Batteries for residents with medical devices**

One TI continues to work with TIDA and an island resident to research back up batteries to purchase for clients with medical devices to use during power outages. The research is a bit more in depth than we originally anticipated, so we hope to have a final recommendation on a battery to purchase by the end of August so we can purchase and distribute in September 2021.
