Security Management Plan Accomplishments

- > Installation of electronic security systems in the hospital.
- > Responded to 1,893 calls-for-service.
- Reduced crimes against persons and property by 43% (221 incidents)
- Reduced use-of-force incidents by 33% (1 incident)
- The approval of the DPH Security Staffing Proposal that includes adding 8 FTE Sheriff's Cadets to provide healthcare security services.


Performance Metrics


Security Management:

Threat Management and Workplace Violence Prevention






Over a 3-year period, moderate and high-risk investigations decreased 96%. There was a 93% decrease in investigations from FY 19-2000.

Threat reports accounted for 50% of the investigations, and 50% of investigations that involved physical violence that occurred in Health Information Services.


Patient against employee reports accounted for 50%, followed by 50% of employee against employee of moderate and high-risk investigations.

- Crimes against Persons and Property decreased 43% from FY 19-2020.
- Battery reports decreased 96% from FY 19-2020.
- Assault reports decreased 100% from FY 19-2020.
- Patient Abuse reports accounted for 99% of reports to SFSO with Resident-on-Resident Altercations (verbal/physical) accounting for 41% of the SOC-341 reports.
- Minus SOC-341 Reports, Crimes against Persons decreased 96%.


Crimes Against Persons and Property



Over a 3-year period, crimes against persons increased 41%. Reported crimes decreased 42% from the previous year. SOC-341 reports decreased 40% from the previous year.


Use of Force

Use-of-force data is tracked of all SFSO incidents occurring on LHH campus. In 2020-2021, there were 2 incidents involving use-of-force. The incidents were analyzed by the types of force, type of incidents, location, cases, demographics, and reported acts by demographics.




 Over 3-year period, use-offorce decreased 50% from FY 2018 and decreased 33% from the previous year.

Use of Force




Fifty percent of use-of-force incidents occurred in the North-3 Unit followed by South -2.




Deputies defending staff from a resident-initiated attacks, followed by returning a resident that eloped, accounted for 100% of physical use-of-force.

Use of Force



Use-of-force against Black/African Americans decreased 50% from the previous year and was flat among all other race/ethnicities.



- Use-of-force is used in response to reports of punching and resident elopement accounted for 100% reported acts.
- Acts committed by Whites were reported 50% followed by Black/African Americans at 50%.
