

Behavioral Health Diagnostic Overview



Roughly 3/4 LHH residents are diagnosed with conditions impacting brain function and behaviors:


- Neurocognitive Disorder Diagnosis (NC)
- Mental Health Diagnosis (MH)
- Substance Use Disorder Diagnosis (SUD)



Substance Use Disorder (SUD) Diagnostic Overview



LHH RESIDENT BEHAVIORAL HEALTH DIAGNOSES



About 1/5 LHH residents have co-occurring SUDs

Most common behavioral health diagnoses for LHH residents



■ MH only: 27%

■ NC only: 13%

■ NC+MH: 13%

■ *MH+SUD: 10%

■ SUD only: 5%

■ *NC+MH+SUD: 3%

■ *NC+SUD: 2%

(* co-occurring disorders makes engaging in specialty SUD treatment challenging)

Referrals for LHH Residents with SUD




In July 2021: **143** LHH residents had SUD Dx in Epic Problem List

- 89% (127) have been referred to LHH Psychiatry
 - 82% (117) were referred before July 2021
 - 7% (10) were referred during July 2021
- 11% (16) were never referred to LHH Psychiatry (since 2017)

Specialty + Non-specialty services

Evidence-based approaches for residents with SUD



Non-specialty

- Overall framework any providers
 - Non-judgmental, trauma informed attitude
 - Harm reduction principles
 - Motivational Interviewing approaches
 - Screening Brief Intervention Referral to Treatment (SBIRT)
- Medical Providers
 - Medication Assisted Therapy (MAT)

Specialty - specialists

- Specialty SUD Treatment: group therapy, individual counseling, MAT
- Specialty Behavioral Health Services:
 - Psychiatric medication management
 - Mental health treatment
 - Behavioral Consultation and Planning
 - Neuropsychological assessment/testing

LHH Psychiatry Services for Referred LHH Residents with SUD



10 LHH residents referred during July 2021

- 100% (10) were followed up by Psychiatry clinician(s)
 - 80% (8) engaged in services in the same month
 - 20% (2) engaged in services later
- Types of services
 - 70% (7) primarily treated for NC and/or MH conditions
 - 30% (3) primarily treated for SUD
 - 1 non-specialty treatment
 - 2 specialty SUD treatment

LHH Psychiatry Services for Referred LHH Residents with SUD



117 LHH residents referred before July 2021

- 100% (117) were followed up by Psychiatry clinician(s)
 - 2 refused services by LHH Psychiatry
 - 115 engaged in LHH Psychiatry services between 1/1/2017-7/30/2021
 - 58% (67) engaged in services prior to July 2021
 - 42% (48) engaged in services during July 2021
- Types of Services for the 115 residents
 - 71% (82) non-SUD services
 - 29% (33) specialty SUD treatment at some point 1/1/2017-7/30/2021

Next Steps



1. Working on comprehensive hospital-wide strategies for opioid overdose prevention

- Implement Harm Reduction approaches
