TREASURE ISLAND DEVELOPMENT AUTHORITY DRAFT MEETING MINUTES

November 10, 2021 – 1:30PM

ORDER OF BUSINESS

1. Call to Order and Roll Call

Present

2. General Public Comment

There was no public comment.

3. Resolution Making Findings to Allow Teleconferenced Meetings Under California Government Code Section 54953(e)

Director Richardson moved Item 3. Director Prochnik seconded the motion. Item 3 was passed by roll call vote.

4. Report by Treasure Island Director

Bob Beck, Treasure Island Director, presented an update on development and operation issues. Director Tsen and Landscape Architect Walter Hood – who is designing Hilltop Park – were recognized by SPUR as recipients of the Silver Spur award.

Local board and committee meetings will not return to in-person meetings prior to January 1. December and January meetings will likely be virtual.

At the request of DPH, Kate Austin is continuing to commit two days a week in her Disaster Service Worker Role as part of the City's COVID-19 response.

The heavy rains over the weekend of October 23-24 presented some significant challenges and there was some localized ponding and flooded roadways. The storm was also a factor in power outages on Yerba Buena & Treasure Island.

We had two additional outages the following week that were the result of vandalism. There were also limited outages to replace transformers or connections on 10/29 (limited to Bayside Drive), 11/1 (effecting two buildings), and this AM (effecting one building). SFPUC will provide an update in December.

Catholic Charities hosted a pair of events for their residents to provide them with an update on the planning for their building on Parcel 3.1.

Pre-marketing window for the 14 affordable for-sale units in the Bristol for Villages Residents has been extended.

SF Glens project team will begin the process of demolishing buildings 261A & B across the street from the gymnasium.

Work to prepare the site for the permanent PG&E gas regulator will require one of the little league fields to be relocated. TIDA Staff & TICD are working with SFLL to identify an alternate site.

SFDPH is currently preparing to roll-out on-Island vaccine distribution for TI residents ages 5-11 years old.

California Academy of Science recently completed their initial two-year survey of Yerba Buena Island coastline and intertidal areas. A TIDA Board or TIDA Sustainability Committee presentation is planned for early 2022 once Cal Academy's data and report are finalized. The Mayor and several City department heads visited TI last week on the SF Prop ferry accompanied by the Developer and several reporters.

Nella Goncalves, One Treasure Island, gave a report.

COVID-19 testing and vaccines continue and DPH has partnered with Residents Supporting Community.

Jamie Brewster, One Treasure Island Employment Program Director, introduced himself and looks forward to joining team and continuing amazing work on island.

The next Construction Training Program will begin in February 2022.

Successful Halloween Trunk or Treat event. Over 50 children attended with families.

Hosting smaller activities with food pantry over holidays.

Nourish Treasure Island has served over 7,000 meals and has been a great success.

A back up battery has been chosen. Order form will go out on Friday.

TI resident Barklee Sanders assisted in testing back up batteries in homes.

Director Richardson and Director Prochnik congratulated Director's Tsen on SPUR recognition. Director Prochnik commented on outages and requested to work with Mr. Beck on questions for the future presentation by PUC.

Director Prochnik requested an alternative to diesel backup generators.

Director Breston commented on back up batteries.

5. Communications From and Received by TIDA

There was no discussion of communications from and received by TIDA.

6. Ongoing Business by Board of Directors

Director Prochnik commented on moving action items up in the agenda.

8. Resolution Establishing an Ad Hoc Nominating Committee, Consisting of Three Members of the Treasure Island Development Authority Board of Directors to Nominate Officers to Serve One Year Term

Director Richardson, Director Kwon, and Director Tsen were nominated to the Ad Hoc Nominating Committee.

Director Richardson moved Item 8.

Director Kwon seconded the motion.

Item 3 was passed by roll call vote.

9. Presentation of Draft TIDA Collections Management Policy

Peter Summerville, TIDA, gave an overview of the TIDA Collections Management Policy.

As a public steward, TIDA has a responsibility for the long-term preservation and maintenance of the historic property and artifacts under its ownership.

Mike Hennahane, Treasure Island Museum, made comments.

Debbie Kahn, Treasure Island Museum, discussed creation, process, and purpose of the Collections Management Policy.

Directors can provide additional comments to Peter Summerville by November 19.

Final version for TIDA Board approval at December 8, 2021 meeting.

Director Tsen asked about how items are being stored and handled and commented on oral history of TI residents.

Director Richardson commented on cataloguing artifacts and oral history project.

10. Resolution Approving and Authorizing License No. 1,382 with Treasure Island Series 2, LLC., a Delaware limited liability company for the use of the Ferry Terminal located on Treasure Island, San Francisco, CA.

Richard Rovetti, TIDA, presented the resolution.

TI Series 2 will dedicate the ferry terminal to TIDA for interim use allowing for ferry service beginning January 2022 in concurrence with first new residents of Yerba Buena Island.

Director Tsen commented on having an opening ride for commissioners and community groups.

Director Prochnik asked if the license gives flexibility to including solar panels in ramp area.

Director Breston asked about the potential traffic impact of new ferry service.

Director Richardson asked to put temporary transportation improvements on the agenda.

Director Richardson moved Item 10.

Director Prochnik seconded the motion.

Item 10 was passed by roll call vote.

11. TIMMA Update on Toll and Discount Policy Draft Recommendations

Rachel Hiatt, TIMMA, provided an update on proposed draft base toll and discount policy. New YBI and TI residential units on sale, planned for occupancy in early 2022. Launch of program planned for mid-2024, subject to closing program funding gaps.

Initial 2024 transit improvements include new bus to Oakland, new ferry to San Francisco, new on-island shuttle, bus to Transbay Terminal, and new bus to SF Civic Center.

Rachel Hiatt reviewed the affordability program.

Proposed for adoption is for all future moderate and low-income drivers to receive discount, and free for very low income.

Rachel Hiatt reviewed base toll policy recommendations, hours of operation, and base rates and discounts.

There will be a Virtual Open House event on November 17, 2021 at 6:00PM.

Director Richardson commented on the significant discounts offered to all low-income drivers including Treasure Island workers.

Suany Chough, TIMMA, discussed funding strategies.

Director Tsen requested Suany Chough come back to have a full presentation and conversation over funding.
