#### 1. CALL TO ORDER

The meeting was called to order at 4:02pm.

#### 2. APPROVAL OF MINUTES FOR MEETING OF NOVEMBER 9, 2021

Action Taken: The Committee unanimously approved the November 9, 2021 minutes.

#### 3. GENERAL PUBLIC COMMENT:

### 4. EXECUTIVE TEAM REPORT

Michael T. Phillips, Chief Executive Officer, presented the item.

### Commissioner Comments:

Commissioner Chow asked for more information regarding LHH resident COVID-19 cases in different units. Dr. Hathaway stated that residents with positive COVID-19 cases are mostly housed in the north tower. These cases seemed linked to roommate and staff cases. She added that these cases do not seem linked to visits or off campus passes. She added that only 3 of the resident cases occurred in unvaccinated individuals

Commissioner Chow asked how often residents are tested. Dr. Hathaway stated that residents were tested every two weeks until January; since that time, testing has occurred twice weekly. Staff are also now tested twice a week.

Commissioner Chow requested updates on support groups regarding Naloxone use. Dr. Hathaway stated that the JCC will receive monthly reports in the PIPS minutes.

Commissioner Green looks forward to data in 6 months related to the plan of correction.

Commissioner Green asked how often staff are fit-tested for masks due to change in weight or facial hair. Mr. Grimes stated that fit tests are conducted once a year due to the large number of LHH staff. Staff may request a fit test if there has been a change in weight or facial hair. He noted that LHH has 13 types of N-95 masks to offer staff. There are also goggles and face shields available. Those staff that work in multiple units (e.g. food workers) must wear a face mask and goggles.

# 5. <u>REGULATORY AFFAIRS REPORT</u>

Geraldine Mariano, Director of Regulatory Affairs, presented the report.

### Commissioner Comments:

Commissioner Chow noted that there have been several thefts in the "Other to Resident" category. Ms. Mariano stated that this category indicates a non-staff member or non-resident had an incident against a resident. She indicated that these situations involved some family members not paying the resident's share of cost or credit card charges.
