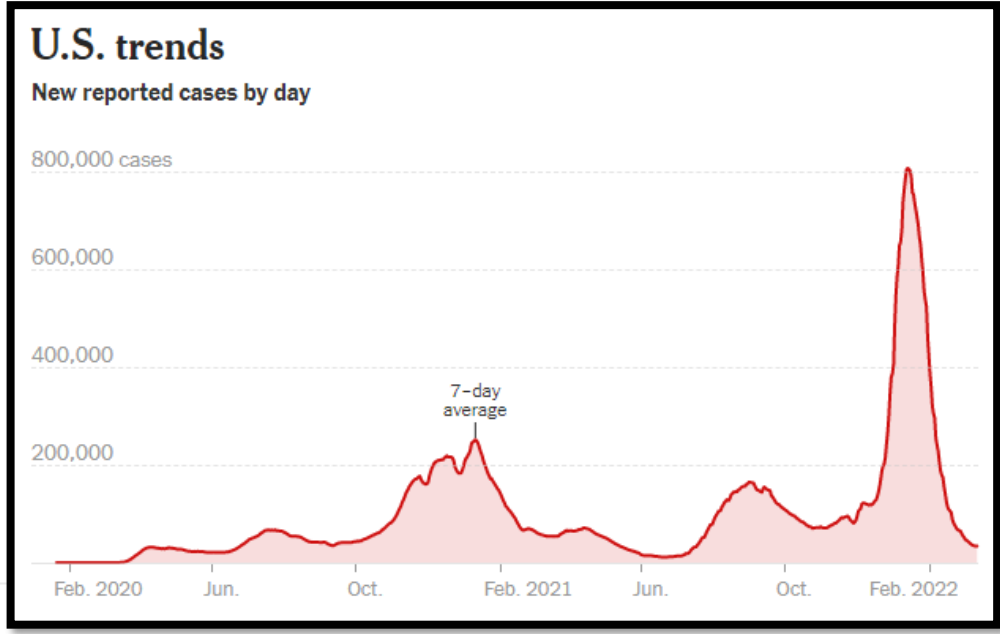
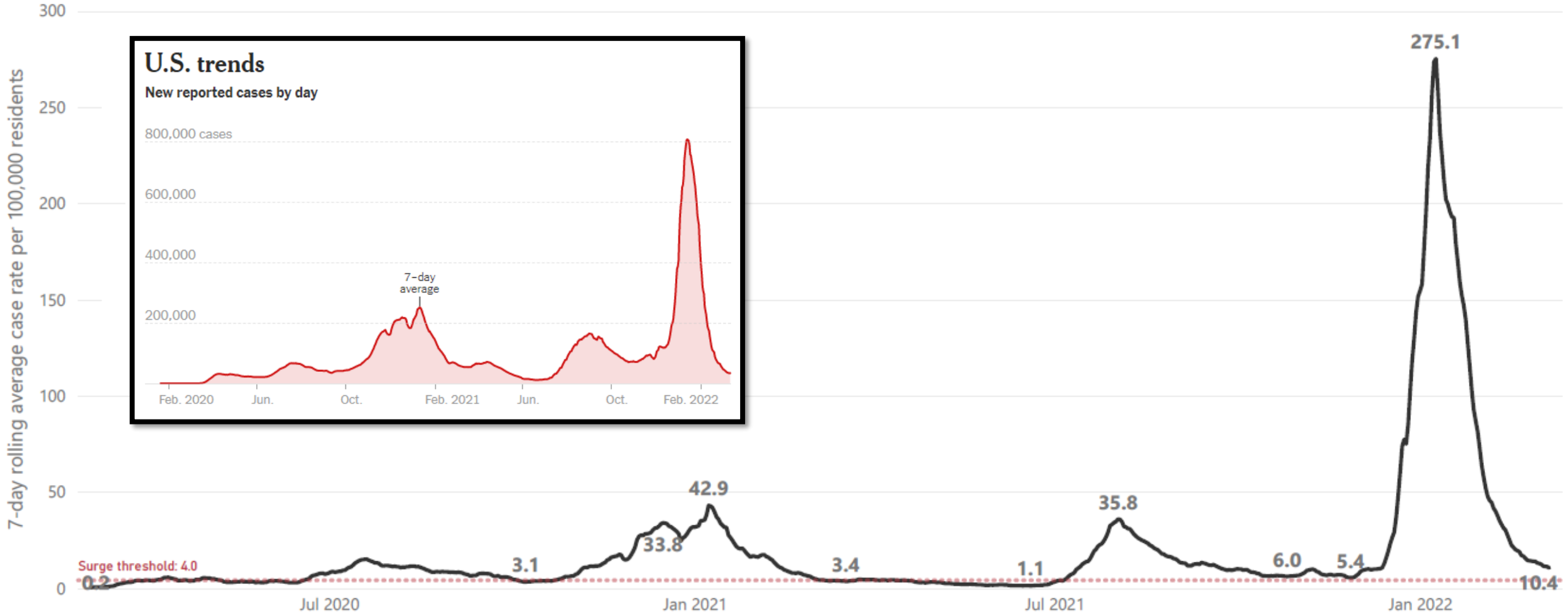

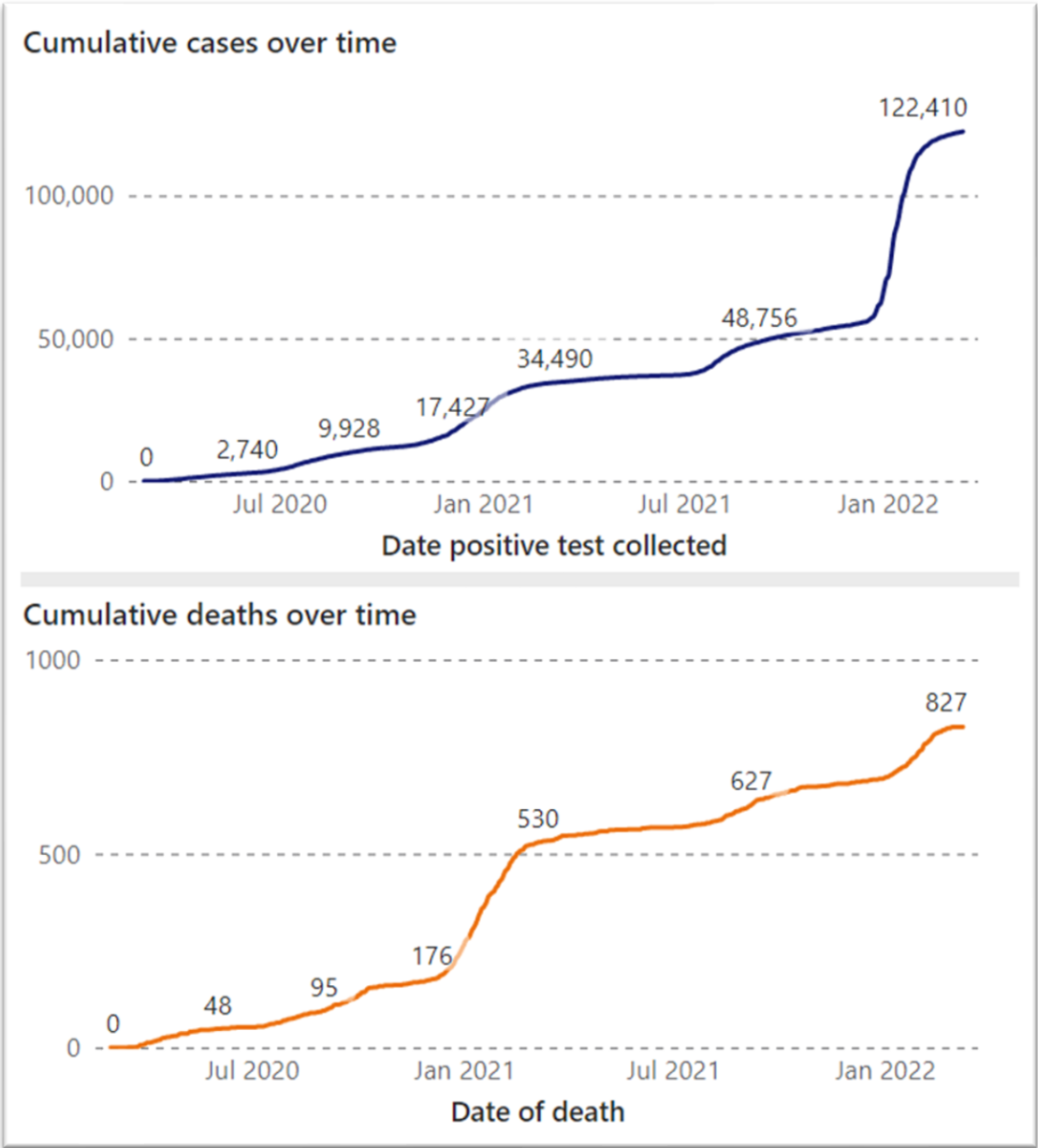
SF COVID cases per 100,000 residents

COVID+ Cases per 100,000 Population (7-day Average)

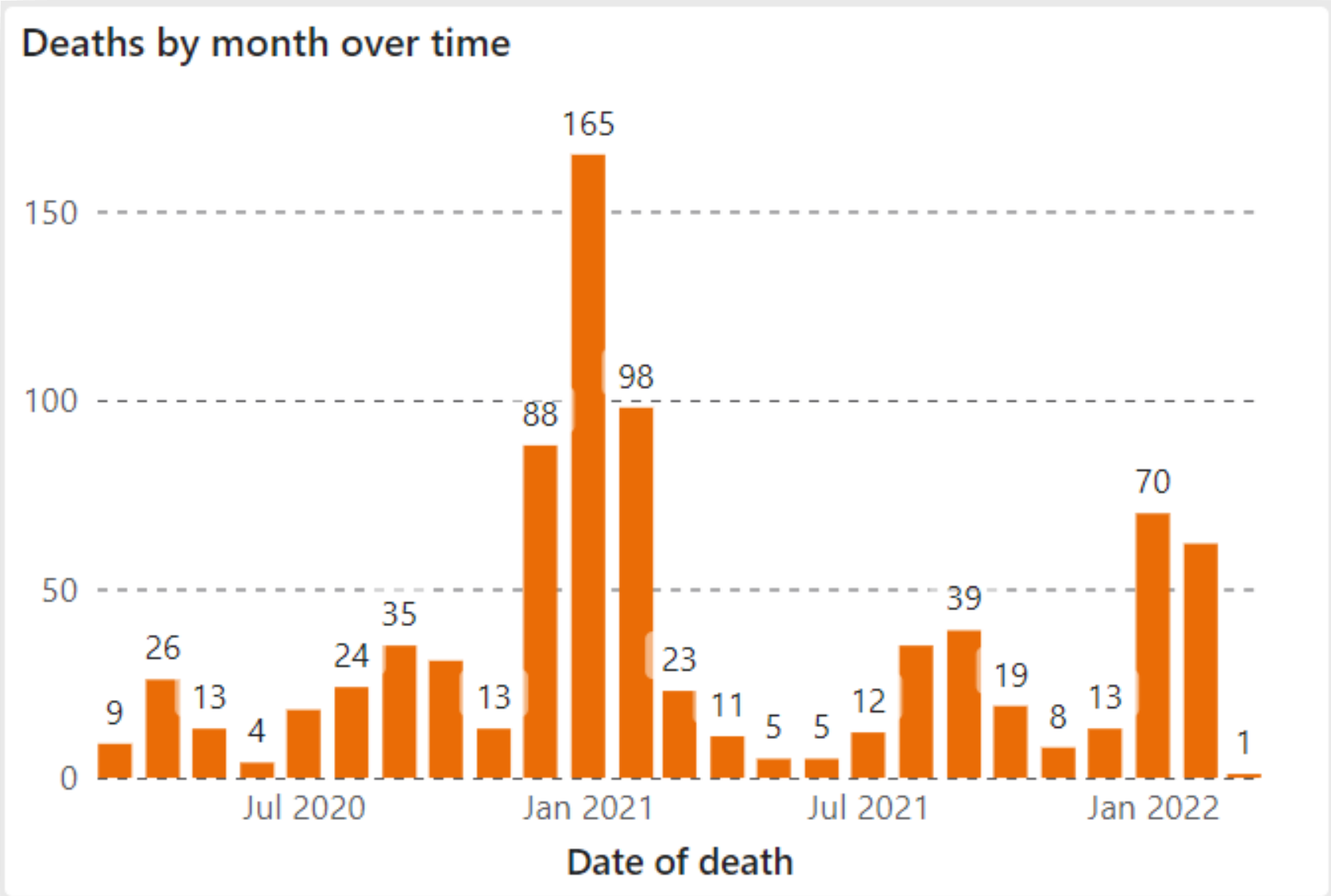

7-day average case rate among unvaccinated residents

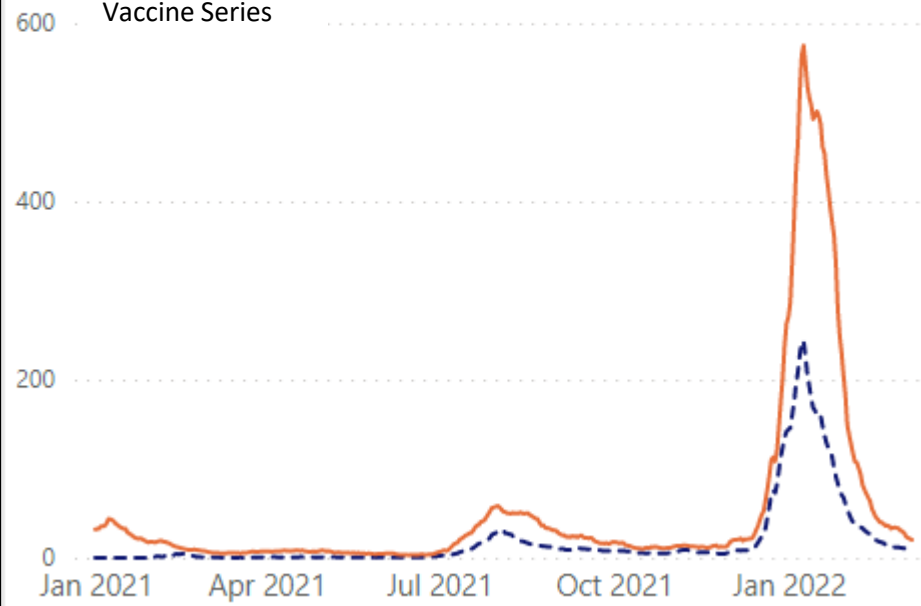

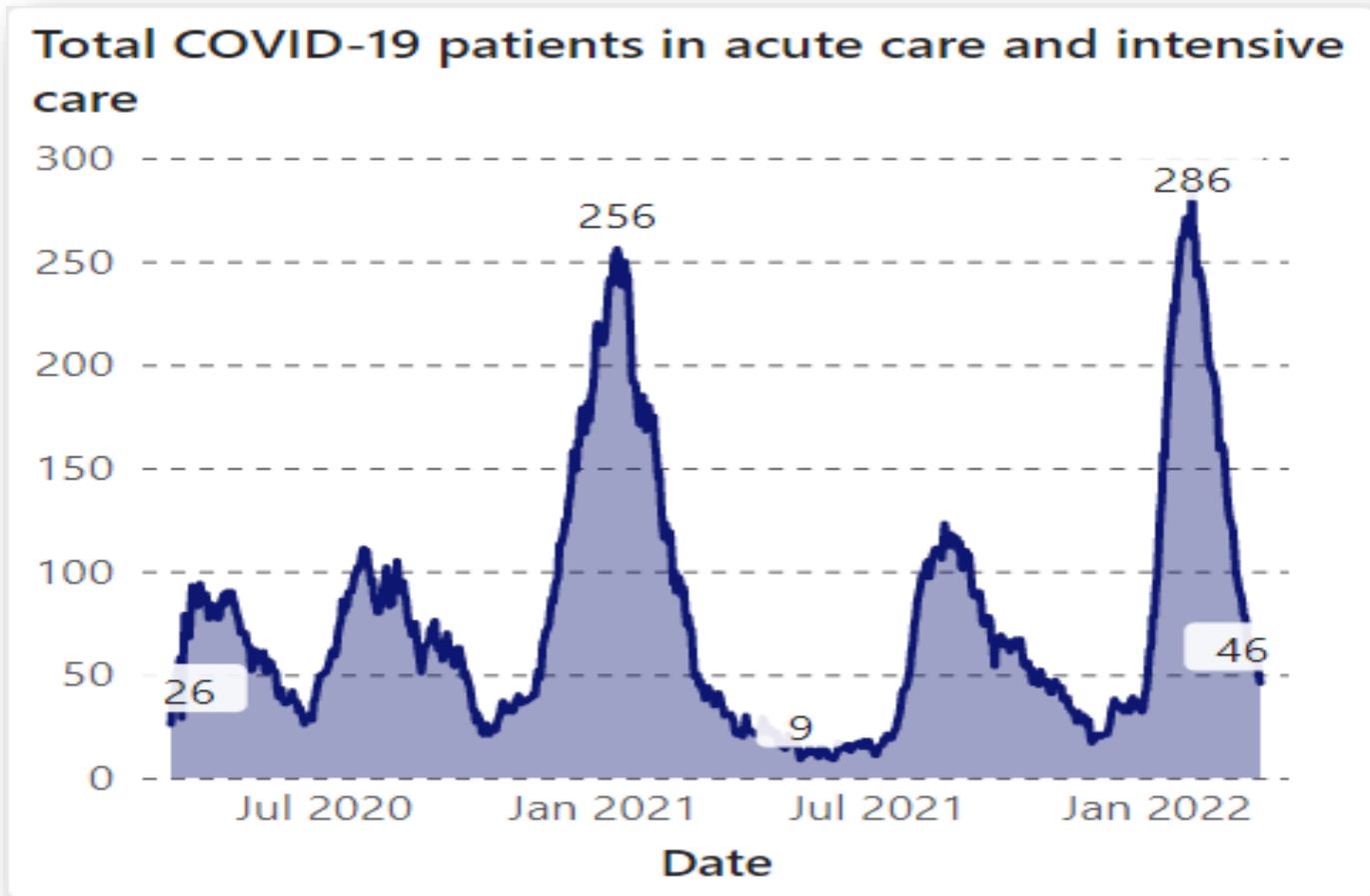

Booster Recipients by Age

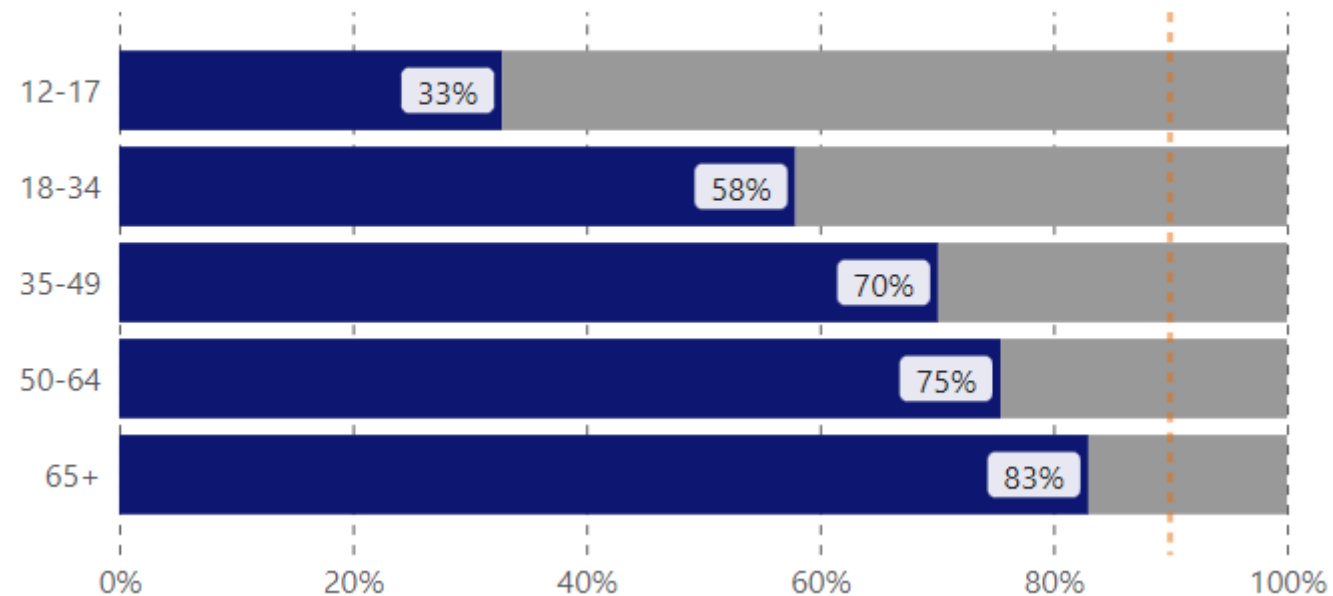
All residents with a vaccine booster

Health Order Changes

As of March 11:

- Patrons/staff of indoor restaurants, bars, gyms, theaters and other entertainment venues no longer have to provide proof of COVID vaccination or a negative COVID test to enter
 - Wearing masks inside such facilities when possible is still strongly recommended
 - Businesses are urged to consider requiring patrons and staff be up-to-date on vaccinations, including boosters
 - Individual businesses continue to be able to adopt more restrictive measures for their own facilities
- No change in pre-entry requirements for indoor mega-events. Per state requirements, proof of initial vaccination or negative COVID test must still be shown when attending an indoor mega-event.



Summary

- COVID case rates and hospitalizations continue to decline in San Francisco.
- Prevention activities continue to focus on vaccinating individuals who need to complete their initial vaccine series or get a booster
- Additional populations may become eligible for initial vaccines/boosters
- Additional variant-driven surges are plausible and our response must be elastic and flexible
