






4. MURAL DESIGN: NARRATIVE AND IMAGES

NARRATIVE: Integrated Art Installation at 681 Florida Affordable Housing Development Project

Crossroads of Flight

The vision for this project is to celebrate the resiliency and vibrancy of the various communities in the Mission District of San Francisco. Conceptual development of the artwork are derived from ideas gathered in the community workshops combined with initial concepts that artists proposed upon application to this project. Some of the main concepts included in these designs include the celebration of history and contemporary storytelling, nativity and immigration, and resiliency through time.

Sabia Tree and Cups of Flames

The ancient, powerful and sacred Sabia represent the resiliency of Americas' native population and indigenous resistance. It is a powerful symbol of the foundation, pillar and strength of communities who are here-long standing and continuing to thrive. In the bottom of the tree is a native wildflower, the California Poppy, sometimes referred to as the "Golden Poppy" and "Cups of Flame", names given by early settlers of California that saw vast displays of California Poppy lighting up the coastal hillsides, guiding their ships by the sight. These two native plants were chosen to tell stories of the native beauty, strength, hope and wisdom through time.

Mayahuel /Colibri (Hummingbird)

Aztec codices of *Mayahuel* are depicted through the maguey plant, a succulent desert plant that has served as an important food source for nearly all the northern and central Mexican tribes and throughout the southwestern Native American nations.

The importance of maguey strongly emphasized within the Latin American visual culture carried in the Mission District. Mayahuel's story of transformation or revitalization of disorder into order also speaks of the resilience of the immigrant populations in the Mission district, amidst the tension of gentrification that have been ongoingly experienced in this neighborhood for years. The blooming flower and the sweet sap of the maguey plant, the *aguamiel*, attracts hummingbirds that symbolizes the power and strength of courageous fighters, the people in this neighborhood, who continue to survive and thrive beyond the limit of their circumstances, showing dignity and pride of their culture, history and contributions. It is also to show the flight of hope and consistent pursuance of exploration and discovery. Birds of the Americas deliver beauty, color and cultural pride and significance for the local migrant and native communities.

Mission Tiles and Housing

The Mission tiles are depicted on the floor of Wall D, a symbol that has been popularized and use by the residents taking pride of their neighborhood. Depictions of housing that are on top of the tiles represents the ongoing fight against displacement and gentrification in the community and a proclamation that in spite of this struggle, the people of the Mission are here to stay.

Resiliency Through Time

Resiliency through time is highlighted in the work as "scenes" or wall panels are designed to take place at different moments in the day. Wall A has a twilight and moonrise theme, while Wall B has sunrise, and Wall D is Midday theme. This time transformations are backgrounds used to represent progress and resiliency through endless infinite time.


