| B - Southern | 4 | 4 | The Officer spoke inappropriately with the complainant, placed the handcuffs too tight, and drove their patrol vehicle in a reckless manner. The complainant was issued citations without cause. The complainant stated that police failed to attend to reports of violent threats |
| C- Bayview | 1 | 2 | The complainant stated that officers failed to investigate a crime as it was reported and in turn wrote an inaccurate report. |
| D - Mission | 7 | - | Officers used unnecessary force on 16-year old juvenile during arrest, resulting in injuries. The complainant witnessed an officer behave aggressively toward street vendors. The complainant stated that the officer and the entire police station dismissed him while he was trying to provide more evidence about his assault and attack. |
| E- Northern | 5 | 2 | The officers failed to investigate a battery and did not write a report. The officer was rude and unhelpful when the complainant requested a protective order for her juvenile daughter who was assaulted at her middle school by another student. |
| F – Park | 1 | - | An officer responded rudely to an inquiry made by the complainant. |
| G - Richmond | 4 | - | Officers failed to investigate a reported vehicle and money theft despite being provided with the suspect's information by the complainant. Officers' |
