

2. General Public Comment

4. Election of Commission Executive Officers

VP Chappell opened nominations for President. VP Chappell nominated herself. Seconded by Commissioner Shapiro.

VP Chappell opened nominations for Vice President. Commissioner Dai nominated Commissioner Jerdonek. He accepted the nomination. VP Chappell nominated Commissioner Shapiro. She accepted the nomination. Public comment was taken.

Majority vote by Commissioners was to elect VP Chappell as President.

After an initial vote for Vice President in which neither candidate received a majority and further discussion on the reasons why Commissioners voted for each of the candidates, Commissioner Shapiro withdrew herself from consideration. Another vote was taken in which Commissioner Jerdonek received a majority.

6. Dominion Voting Systems Contract Extension

VP-Elect Jerdonek presented a draft "Resolution on Extending the City's Contract with Dominion Voting Systems," including changes that were made when the resolution was discussed at a prior meeting. Two clauses (Page 2, WHEREAS clauses at Lines 10 and 14) were brought to the Commission's attention by President-Elect Chappell and Vice President-Elect Jerdonek for further discussion.

violates the non-interference clause between the Commission and the Department of Elections. DCA Flores confirmed that it did not.

VP-Elect Jerdonek moved to adopt the resolution as revised in the packet. Seconded by Commissioner Shapiro.

David Pilpel commented on clauses included in the Resolution.

7. Redistricting Process Initiative

With Commissioner Shapiro's assistance, Commissioner Dai introduced a proposed plan for a public forum on how to improve San Francisco's Redistricting process. Notes were posted in this meeting's packet.

Other items submitted in the meeting packet were discussed to draw attention to recommendations.

Commissioner Bernholz suggested <u>constraining</u> the scope of project to redistricting for supervisorial districts (while acknowledging other ways improve democratic outcomes).

VP-elect Jerdonek commented on whether the selection of appointees and timeline could be added to the list of items for consideration. The Commission discussed whether some of the suggestions are beyond the scope of the Elections Commission. President-Elect Chappell expressed concern about the appropriateness of this commission to spearhead this project and potential challenges.

Speaker Steven Hill, <u>co-founder of FairVote and previous advisor to the 1996 Elections</u> <u>Task Force</u>, provided background regarding the history of redistricting in San Francisco and the processes used to develop <u>initial</u> district maps. VP-Elect Jerdonek asked about the charter amendment that created the Redistricting Task Force (RTF) in the beginning. Mr. Hill responded that Proposition G started in 1996. Deleted: boundaries on

Speaker Julia Marks, Voting Rights Manager for Asian Law Caucus, shared information on local redistricting and legislation affecting redistricting bodies throughout the State of California. Commissioner Shapiro asked about ranked criteria. Commissioners asked Ms. Marks questions about her presentation.

After discussion, the Commission agreed to continue with the educational portion of the Initiative over the next few meetings and defer possible action after that.

Public Comment

David Pilpel commented on the need for a charter amendment to make changes to the RTF and explained that the Board of Supervisors would have to be consulted.

Jen Tse from the League of Women Voters commended the Commission for the great presentations by the speakers and supported efforts made by the Commission on redistricting.

8. Director's Report

Director Arntz provided a report on the status of all functions of the Department.

VP-Elect Jerdonek asked Director Arntz about the percentage of voters that are reached for curing their vote-by-mail ballot.

Commissioner Shapiro asked how the department educates the public and the media regarding voting statistics on and around Election Day. She also asked questions regarding the process of counting ballots.

Public Comment

David Pilpel commented on the June and November elections regarding reporting on ballots and stated that the Department operates with transparency and efficiency.

VP-Elect Jerdonek commented on documents submitted and posted on the website packet.

David Pilpel pointed out that some voting information can be located on postings of the Director's press releases.
