#### Psychiatric Emergency Services (PES) Zuckerberg San Francisco General Hospital

- Licensed for 18 patients; not to exceed 23 hours length of stay; patients routinely in hallways
- The only dedicated 24/7 secure (locked) psychiatric emergency service in San Francisco
- Emergency assessment and treatment of mental health, substance use, and medical conditions
- Linkage to follow-up services
- Receives both voluntary and involuntary (5150 and conserved) patients
- Census capped at 20-21 patients due to limited space

## **Multidisciplinary Psychiatric Staffing**

- Psychiatrists (24/7) and Psychiatric Nurse Practitioners
- Psychiatric Nurses and Licensed Psychiatric Technicians (1 staff to 4 patient ratio at all times)
- Psychiatric Social Workers placement and linkage
- Psychiatric Occupational Therapists life skills assessment, coping skills enhancement
- Patient Navigator accompanies patients to next step

# PES Open for the City throughout COVID Pandemic

- Pivoted to all psychiatric patients arriving at ZSFG ED for COVID clearance (rather than pre-COVID direct to PES)
- "100% PES Condition Red" = "Go to the ZSFG ED first!"
- Patients triaged, assessed, and treated by PES psychiatrist in the ED with Behavioral Emergency Response Team (BERT) and PES nursing support
- Currently 60% of psychiatric patients presenting to ED go directly to PES from ED Triage without entering ED
- Psychiatrist d/c's 1/3 of patients seen the ED (PES bypassed)

# **PES Linkage to Ongoing Treatment**

- 13% admitted for acute inpatient psychiatric treatment
- 7% admitted to Hummingbird Psychiatric Respite (DPH BHS expanded beds by 80% in 2021)
- 6% transferred to Dore Urgent Care Clinic (Behavioral Health)
- 59% discharged with outpatient referrals


# **DPH BHS/PES Linkage Innovations**

- 120% increase in discharge medications (psychotropics and naloxone) provided to patients leaving PES during pandemic
- DPH BHS BEST Team linkage case managers come to PES to meet and link with patients before they leave PES
- DPH BHS helped strengthen partnerships with HealthRight360 to provide reserved detox beds, and with Salvation Army Harbor Lights to streamline referrals
- Increased intensive case management referrals to Transitional Age Youth Acute Linkage, Citywide Linkage, BHS Office of Coordinated Care (OCC)


## Citywide PES Linkage Team

- Intensive PES-based case management interventions have been able to link patients who are high users of PES to transitional housing or shelter (with reduced visits to PES)
- Patients are able to get short-term ongoing medication services from the Citywide PES Linkage Team psychiatrist
- The ultimate goal is stable linkage with DPH BHS clinic-based services


#### **PES Admissions (Number of Episodes)**

## Future State PES (2026)

- Building 5 1<sup>st</sup> floor, SE corner opening onto Dr. David Sanchez Way
- Dayroom clinical space expanded by 300% with open sightlines for increased patient and staff safety
- Private/seclusion rooms increased from 4 -> 6 (50%)
- Separate Exit sally port added (2 sally ports) for extra security/safety
- Expanded Triage area for safety/privacy
- Dedicated Citywide PES case management office space with safe patient access

#### Future State PES (2026)

- Potential for expansion of census from 20 -> 24/28 patients (1:4 ratio most economically efficient)
- Nursing/Medical staffing expansion budget proposal to be submitted October 2024
- Efficient utilization of PES services requires improved access to shelter resources for unhoused patients 24/7
