### **Ramaytush Ohlone land acknowledgement**

We acknowledge that we are on the unceded ancestral homeland of the Ramaytush Ohlone who are the original inhabitants of the San Francisco Peninsula. We wish to pay our respects by acknowledging the ancestors, elders and relatives of the Ramaytush Community and by affirming their sovereign rights as First Peoples.

### **Public Comment:**

Members of the San Francisco Finance Corporation will attend this meeting in-person. Members of the public are invited to observe the meeting in-person or remotely online as described herein. Members of the public attending the meeting in person will have an opportunity to provide public comment on every item.

In addition to in-person public comment, the San Francisco Finance Corporation will hear up to three minutes of remote public comment on each agenda item. The San Francisco Finance Corporation will hear remote public comment on each item in the order that commenters add themselves to the queue to comment on the item. Because of the three-minute time limit, it is possible that not every person in the queue will have an opportunity to provide remote public comment. Remote public comment from people who have received an accommodation due to disability (as described below) will not count toward the three-minute limit.
