- I attended an Oak Street update that SFBC put on a couple of weeks ago at Flywheel Cafe. I have invited the team to present their latest proposed changes to this committee, which will happen in either June or July, so stay tuned. Reminder that this will remove one lane of car traffic to have parking protected bike lane on Oak. Of things I think there could be good feedback from us is the main intersections at Masonic and the end at Baker that will move from the left side of Oak to the right side of Oak.
- This past Saturday there was Wiggle Fest. I was unable to attend, but got a recap from the organizers of Page Slow Street. That Safe Streets Rebel has crafted an email campaign to get Steiner closed to car traffic as part of SFMTA's biking and rolling plan. The email, in part, reads
  - We're demanding that the city immediately draft and implement plans to:
  - Remove cars and vehicle traffic from Steiner to extend and improve access to Duboce Park for the elderly and disabled residents who live nearby. This would immediately and inexpensively fix the very dangerous intersection at Steiner, Duboce and Sanchez.
  - Add Slow Streets style diverters and median soft hit posts along the Wiggle to prevent cars speeding past bikes, a regular occurrence on the Wiggle currently.
  - Eliminate eastbound car traffic on Duboce between Belcher and Church and make this busy intersection of the Wiggle and Muni 22 and N lines a car-free plaza.
  - Fully daylight every intersection along the entire corridor to 20 feet from each crosswalk and install bike corrals, benches and planters in each daylit space.

- D8: nothing for my district specifically,
  - On Valencia, I've seen a lot of young people on motorized dirt bikes ride in the bike lane, and it's dangerous and I don't see anything to make them stop.
- D9: I'm enjoying not getting hit by cars while riding down the middle bike lane. That's all I have to report.

  - What about all the posts that are constantly smashed in the hairball.
    - Jean Long has inquired about them, will ask the Livable Streets contact to escalate and get a status update.
  - D4: re dirtbike, had a meeting with Sunset/Taraval station police efforts, the captain was reluctant to deal with how to enforce any laws against them.

- D9: police chief indicated they are going to re-engage on enforcement, which was supposedly due to understaffing.

  - D9: there's a proposed a bike lane on Frida Kahlo way. It's controversial and pushback from people in the neighborhood due to loss of parking
