individual Commissioners or Department personnel. The lack of a response by the Commissioners or Department personnel does not necessarily constitute agreement with, or support of, statements made during public comment.

Public comment may be made:

- 1) In person at the meeting.

- 3) By email to <u>JUV-ProbationCommission@sfgov.org</u> if received no later than 12:00pm the Friday before the meeting.
- 4) By leaving voicemail at 415-753-7556. Comments submitted no later than 12:00pm the Friday before the meeting will be read into the record during the meeting and will be treated as a substitute to providing public comment during the meeting.

NOTE: Persons who submit by written public comment or by voice mail in advance on an agenda item will not be permitted to also provide public comment on the same agenda item(s) in-person during the meeting.
