Highlights For June 12, 2024

The following report includes the Department of Police Accountability's recent developments:

- ◆ DPA's Audit Division and the Controller followed up on SFPD's implementation of recommendations from the 2020 Use of Force audit.
- ◆ DPA's Outreach will be participating in Juneteenth and Pride events during the month.
- ◆ DPA Interns will be updating "Know Your Rights" pamphlets as their summer project.

Investigation Updates

- ◆ **Cases Opened/Closed:** Our office opened 8 new cases and closed 13 cases since the last Commission meeting.
- ◆ **Cases Pending:** Our pending cases have remained constant over the last month.
- ◆ **Cases Sustained:** We have sustained one case since the last Commission meeting.

Investigations Over 270-Days/Tolling

The DPA has 22 cases open for more than 270 days. Of those, 18 cases (88%) are “tolled”.

Note: Per California Government Code Section 3304, there are several exceptions that “toll,” or pause, one-year statute of limitations.

This year, **DPA has conducted an increasing number of resource intensive investigations** involving multiple officers, complex data analysis, and the need to obtain court orders. Examples include:

- ◆ Officer involved shooting investigation closures.
- ◆ Investigations involving juveniles requiring DPA to seek a court order.
- ◆ Investigations involving stop data collection required by California state law.

DPA Sustained Cases Pending Final Adjudication

- ◆ There are 127 cases sustained by DPA that are pending with the Chief.
- ◆ There are 13 cases pending with the San Francisco Police Commission.

Other DPA Updates

- ◆ **Audit:** As of May 28, 4 of 37 recommendations from the 2020 Use of Force Audit remain open. The recommendations relate to incident report writing, use of force data testing, and publishing use of force data on the Department’s open data portal.
- ◆ **Outreach:** DPA Outreach and interns participated in the Juneteenth parade and will be present at several Juneteenth and Pride events throughout the month.
- ◆ **Policy:** Attended the Emergency Vehicle Operation Course and met with the EVOC team as part of DGO 5.05 revisions.
