



Verbal abuse can include the act of harassing, labeling, insulting, scolding, rebuking, or excessive yelling towards an individual) was reported to the State Survey Agency (SSA) within the required timeframe of two hours for one sampled resident (Resident 1) when Resident 1 reported a verbal altercation with Security Guard (SG) 2.		






Outcome of FRIs 2019,2020,2021




Outcome of FRIs 2022,2023,2024




Staff to Res Abuse 2019-2021




Staff to Res Abuse 2022-2024
