C. NEW APPEAL(S): Order of Abatement (Discussion and Action)

1. CASE NO. 6924: 204 Tingley St. - Complaint # 202173591

Owners of Record & Appellant: AHMAD LARIZADEH

ACTION REQUESTED BY APPELLANT: Appellant appeals the Order of Abatement dated February 7, 2023, and assessment of costs. Appellant seeks "no lien is bestowed on subject property: 204 Tingley St. City of SF destroyed plans/app in 2020. Due to hardship, permit was not processed in time of Director's hearing. Duplicate is being processed now with the city of SF."

Public Comment

There was no public comment.

Senior Building Inspector Joe Ng presented the Department's case regarding $311 - 11^{th}$ Avenue and made the following points:

- The property was a one-story building.
- Complaint filed February 2021 an investigation revealed unauthorized rear addition constructed without a building permit.
- The wood frame structure was not weatherized increasing fire hazard.
- The inspector found the same property owner had the same violation twelve years ago and an Order of Abatement (OOA) was issued July 2013.

- Member of the public filed new complaint February 2021 and a Notice of Violation (NOV) was issued and another OOA with conditions was filed.
- June 2023 the owner obtained a permit but work had not been completed to date.
- The last DBI inspection was completed August 2023 and it was found the completed work was not fully in line with the approved drawings.
- Staff recommended to uphold the OOA and assessment of cost.

The appellant Carmen Carrizales was late and upon arrival it was determined language services were needed. Commissioner Williams suggested the hearing be continued to July 2024.

Vice President Neumann made a motion to continue case #6924 to the next Abatement Appeals Board meeting of July 17, 2024, seconded by Commissioner Williams.
