RE: **Annual Report of Gifts Received in FY 2023-24**

As required by section 10.100-201 of the San Francisco Administrative Code and consistent with the policy and procedure for the acceptance of gifts adopted by the Health Commission in October 1995, this is the annual report of gifts received in FY 23-24.

During FY 23-24, DPH received approximately \$148K in gifts from 23 separate donors. Of these 23, the majority were donations to Laguna Honda Hospital totaling approximately \$105K mainly for care and general benefit and comfort of patients. Separate donations totaling \$29K and \$14K were made to Central DPH and Zuckerberg San Francisco General Hospital, respectively.

Gifts received during FY 23-24 were substantially decreased from the prior year due to the reduction of Covid-19 test kits from state and federal sources, which accounted for over \$3.3M of the approximately \$3.5M received during FY 22-23.
