**Purpose of Contract:**

Since FY 2020-2021, Zuckerberg San Francisco General Hospital has averaged 1110 babies born. ZSFG has a continued need for an early warning and prevention solution for infant abductions. ZSFG currently has a Hugs Lonworks solution where small tags are placed on infants and children, they are monitored through a real time location system (RTLs), shows infant and child's location, and instant alerts are generated when certain geo-fence parameters are triggered. The Hugs Lonworks solution is sunseting and being replaced with the new Hugs Wifi solution. Every infant wears a Wi-Fi Hugs tag on the ankle that is attached with a special tamper-detecting band. The tag activates the moment it is attached and is automatically enrolled in the system. The tags offer both exit protection and tamper detection. This contract will support the new software, equipment, implementation, and ongoing maintenance. Securitas Healthcare runs both Hugs Lonworks solution and the new Hugs Wifi solution.

Securitas Healthcare LLC is a subsidiary of Securitas USA and global parent company Securitas AB, originally founded in Helsingborg, Sweden in 1934. Since founded, Securitas AB made global expansion efforts and several acquisitions, including Stanley Securitas Solutions and Stanley Black & Decker. Securitas is the Leader in protective services. It's parent company, Securitas AB, a public traded, is headquartered in Stockholm, Sweden and employs over 370,000 people in 58 countries.
