3. Approval of previous meeting minutes

March and April meeting minutes were approved after Commissioner Dai indicated she had submitted some edits and also questioned some abbreviated details. President Stone reminded the Commission that minutes should be an overview of action items and resolutions as per the agenda items. 4. Director's Report

Director Arntz presented his May report and answered questions. He noted that Friday 17 is the beginning of the nomination period for candidates to file for mayor and board supervisor contests. Commissioner Wong expressed her appreciation for the non-citizen voting reformatted web page and also said she would be interested in attending the June language accessibility advisory committee meeting. She also had questions regarding the potential response of the Election Department regarding election disinformation and related response(s) to election issues, especially AI matters. The Elections Department will respond to voting/site issues related to election operations but does not review or regulate campaign speech. The Department has attended hearings at the request of Supervisor Preston and will continue to be a part of the discussion regarding AI and its potential role in elections matters. Commissioner LiVolsi asked about the Racial Equity Report and registration as the result of outreach.

City Attorney Russi clarified that the City does not have a standard evaluation form/process that could be used in this instance.
