ANNUAL REPORT REQUIREMENT

Per Government Code Section 7071 (e)(1):

"The governing body shall determine, based on the annual military equipment report..., whether each type of military equipment identified in that report has complied with the standards for approval... If the governing body determines that a type of military equipment identified in that annual military equipment report has not complied with the standards for approval..., the governing body shall either disapprove a renewal of the authorization for that type of military equipment or require modifications to the military equipment use policy in a manner that will resolve the lack of compliance."



2023 ANNUAL REPORT – NEXT STEPS

2023 Annual Report Approval Process

- The 2023 annual report will be submitted with a resolution requesting the Board of Supervisors, as the governing board, review and approve the report.
- The resolution will be scheduled for a Government Audit and Oversight (GAO)
 Committee hearing tentatively scheduled for September 19, at which staff will present and answer committee members' questions.
- The GAO Committee can refer the resolution to the Board of Supervisors with or without a recommendation, amend it, or continue it.
- Once referred to the Board of Supervisors, the Board will vote whether to adopt the resolution, thereby approving the annual report.



FUTURE ANNUAL REPORTS



- 1. October December 2024: Complete the 2024 annual report by end of year.
- 2. January 2025: 2024 annual report will be posted on the SFPD website. Within 30 days, SFPD will hold at least one well-publicized community engagement meeting where community members can actively engage, ask questions, and discuss issues.
- **3. February 2025:** Annual report and community engagement feedback presented at the Police Commission.
- **4. Mid February 2025:** Submit the annual report to the Board of Supervisors with a resolution requesting approval.
