## **Admissions Update**



## Welcoming back former residents and expanding to new admissions

- Laguna Honda has contacted all former residents who were transferred at the direction of CMS.
- Since resuming admissions, Laguna Honda has admitted 7 former residents and 1 new admission.
- We thank all teams involved in admissions planning for making this possible, as well as our unit staff and resident care teams.

### **Admissions Plan**



#### Deliberate and gradual approach to admissions

Priority #1: **Former Laguna Honda residents** Priority #2: San Franciscans not in medical settings Priority #3: **Eligible SFHN patients** Priority #4: San Franciscans receiving SNF and/or rehabilitation services in other facilities Priority #5: Patients at non-SFHN medical facilities

## **COVID-19 Update**



#### **Continued decrease in COVID-19 cases**

- Laguna Honda officially ended outbreak status for COVID-19 on August 27, 2024.
- As of September 5, 2024, there are zero units on outbreak status, with 0 active resident case and 6 active staff cases.
- Certain precautions remain in effect given that skilled nursing settings are more vulnerable to respiratory illnesses, including masking facility-wide.
- As of September 5, 68% of residents are up-to-date on their vaccine.

#### **COVID-19** and Flu Vaccines



#### Vaccine preparations underway

- Laguna Honda is preparing for the arrival of the updated COVID-19 and flu vaccines.
- Teams are coordinating robust resident and staff campaigns to ensure high vaccine rates.
- We anticipate partnering with a local pharmacy to host several vaccine clinics onsite for staff as part of a statewide long term care vaccination program.
- Laguna Honda will again lead resident vaccinations, and we are preparing by collecting consents as we await the arrival of the vaccines.





## **Certification Update**



#### **Update on triple rooms at Laguna Honda**


- Laguna Honda is committed to recertifying the 120 beds that we were required to remove based on federal Centers for Medicare and Medicaid (CMS) regulations.
- We continue to make clear to the California Department for Public Health (CDPH) and CMS the need to recertify the 120 beds and in turn, CDPH and CMS have made clear they are prepared to receive and consider a waiver application once Laguna Honda has demonstrated a sustained period of regulatory compliance.
- Laguna Honda will submit the waiver application at the earliest opportunity to ensure success.

## **Discharge Update**



#### Process to discharge residents with non-SNF level of care

 Laguna Honda is actively working to discharge residents who no longer require skilled nursing facility-level (SNF) care.






## State of the Hospital
