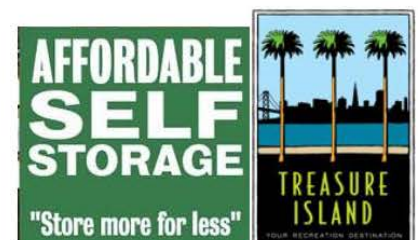
Monthly permit fee is \$150/month. Due to limited capacity, each household may apply for one parking space.

**The reinvention of this S.F. island is undergoing its first phase — the rest will take decades**

There's no stranger slice of San Francisco right now than the one that begins 2 miles northeast of the [Embarcadero](#), on [Treasure Island](#).

Freshly planted shasta daisies and toyon trees line a 22-story luxury high-rise that is almost ready to open, across the street from an empty lot with dirt piled 10 feet high. On the tower's other side is a condominium project wrapped in scaffolding and, beyond that, a fenced-off job training center for low-income youth.

Another fence lines the nearby shoreline — but that one screens construction crews at work on a 6-acre waterfront park set to open next year.

You get the picture: The reinvention of the 425-acre island created in the 1930s out of rubble and sand to hold the Golden Gate International Exposition is a work in progress that likely will continue for decades. But the first phase is far enough along that if you're curious about how urban landscapes emerge and mature, this is the summer to start taking notes.

The work completed so far includes three residential buildings and the streetscapes along them, as well as the miniature ferry terminal [that began service in 2022](#). Two six-story market-rate housing complexes are sheathed but fully shaped en route to debuting by next summer, around the same time as the bayside park with dead-on views of San Francisco's downtown skyline and home-shrouded hills. There also are townhomes and condominiums [tucked into the slopes](#) of adjacent Yerba Buena Island, as well as [Hiroshi Sugimoto's needle-thin](#) "Point of Infinity" sculpture.

But any large transformation needs a visual hook to alert the public that big changes have arrived. That's what Treasure Island now has with Isle House, the 250-unit apartment tower designed by David Baker Architects for Wilson Meany and Stockbridge, part of the islands' master development team.

Baker has made his mark with [inventive low-income housing](#) such as 222 Taylor St. in the Tenderloin, or such [stylish complexes](#) as Hayes Valley's 300 Ivy St. This is the firm's first high-rise, easily viewed from the Embarcadero as a vertical accent to Treasure Island's tabletop terrain.

From this perspective there's not much going on, a tall squat cube with a flat top and a pale skin. It's when you step off the quick ferry from the Ferry Building (where else?) that Isle House's urbane poise comes into focus.

For starters, the simple rectangle isn't so simple: The tower is set apart from a six-story base by a recessed floor clad largely in glass. From there on up, serrated but subtle bays enliven the dimensions without being choppy.

Many architects would do that one twist and call it a day. Baker keeps going.

The bottom two levels are black brick while the rest of the base wears a randomized mix of three shades of gray tiles. Above *that*, Baker shifts to clean white plaster — and arranges that plaster in strong upward strips, rather than punched windows or horizontal bands. The pattern is evocative of the stylish vintage airplane hangars along nearby Clipper Cove, a reminder that historical allusions have a place in contemporary design.

A wholly different approach to Treasure Island's renewal is two blocks to the north at Star View Court, where people this summer began moving into the seven-story structure that holds 138 apartments stacked around a long central courtyard.

Unlike Isle House, which consists almost entirely of market-rate apartments, Star View Court is reserved for low-income residents. This includes 94 that are set aside for households — many of them formerly homeless — who already live on the island in what originally was military housing. Those blocks of suburban-style homes will likely remain for at least the next decade, along with the island's scattering of restaurants among the older buildings.

The emphasis on income diversity is constant in the redevelopment plans, with approximately 2,200 of the eventual 8,000 units to be priced at below-market levels. But the plans also call for a uniform level of building quality, and Star View Court fits seamlessly into the emerging landscape.

Along Seven Seas Avenue, which serves as Treasure Island's main north-south roadway, the building developed by Mercy Housing is a seven-story bar in muted tones of white and gray. On the pedestrian-scaled mid-block alley to the west, heights drop to four stories with porches

fanning out along the way. The closest thing to an architectural flourish comes where the two sides meet in a glassy community room that juts out from the second floor — it faces an empty lot that someday will be a park — and is backed by a metal-screened open walkway for residents and their guests.

“With affordable housing you only get a few shots to do something interesting” in terms of design, said Eric Robinson, a principal at Paulett Taggart Architects, the project’s designer. “You need to be strategic.”

Put another way: If Isle House is aimed at residents with high discretionary incomes, Star Court adds to the district character not just architecturally, but by providing a good home for people who might have few other options. That latter goal is palpable inside, whether strolling through the lobby with its chic bamboo screen that both absorbs noise and hides the mail alcove, or the central courtyard that consists of planter-framed spaces spilling one into the next.

As for the design affinity between the two new buildings — those white plaster walls, for instance — it’s no accident.

The island’s redevelopment plan is accompanied by design standards encouraging buildings that are similar to each other without feeling boilerplate. Two examples: The window-to-wall ratio for each structure is set at 50%, and light masonry tones are encouraged over metal panels or bold colors.

“The architectural ethos is to make really cohesive neighborhoods with buildings that are distinguished, yet diverse,” said Craig Hartman, a consulting partner of Skidmore, Owings & Merrill who was central to the island’s planning and design principles. “There will be lessons learned along the way, but it’s a strong framework.”

The effort to craft a unified tone can also be gleaned in the mid-block alleys of the first phase with their drought-tolerant landscaping and the tough-looking benches and bike racks forged from cast iron. This aspect of the plan is the work of CMG Landscape Architecture, which also designed the shoreline park now taking shape.

The park’s debut will be next summer at the earliest — but the obviously new level of riprap along the edges offers a clue to how Treasure Island’s rebranding isn’t just buildings and parks. All the new parkland and development sites are perched 3.5 feet above the older portions of the island, a height calibrated to long-term projections for sea level rise.

None of this happens by chance.

Planning for the islands’ future began even before the U.S. Navy closed its base in the middle of the bay in 1997. San Francisco’s Board of Supervisors in 2007 approved the plan, done by Perkins & Will as well as SOM. Construction crews in 2015 began raising the edges and [tamping down the soil](#) — the latter a response to seismic concerns, not just climate change.

The new buildings we see aren't the end of the story: Cityside Park and the two scaffolded market-rate condo projects should open by next fall. By then, work will be under way of the renovation of the chapel building across from Isle House and the conversion of the empty land around it into a "cultural park," also designed by CMG.

As for the handful of remaining housing sites in the project's first phase, construction won't begin until the first wave is absorbed.

"There are periods where the market is difficult, and periods where things seem to get built overnight," said Chris Meany, who joined the development team in 2005.

Despite the wait, and the inevitable lawsuits and economic jostles along the way, "in another 20 years, this will be one of the great created neighborhoods in the country," Meany promised this month. "I'm convinced of that."

It's much too early to tell whether Meany's confidence will bear fruit. But judging by the puzzle's first pieces, such claims aren't just hype.

#### **Here's what I enjoyed on my first visit to Treasure Island**

A ferry ride away, Treasure Island is a mishmash of urban development and eerie desolation, nice wineries alongside abandoned military buildings.

I visited Treasure Island for the first time in my life a few months ago. Having lived in San Francisco for many years, I wouldn't exactly call this spot a tourist mecca; It's been nearly three decades since the U.S. Navy vacated the island, and we're still shy of 3,000 people living there.

They're working hard to grow that number: A [major redevelopment plan](#) calls for all residences to be within a 10-minute walk of all basic amenities. But what's Treasure Island like today, and how did it evolve into this?

Treasure Island is an entirely artificial creation. In the 1930s, engineers piled mud that was dredged from the bay onto a shoal next to Yerba Buena Island; Tons of bay muck was transformed into [a 400-acre plot](#) to house the Golden Gate International Exposition, the island's World's Fair site. It has since been home to a naval station, psychiatric ward, and playground for Hollywood films.

Today, Treasure Island is a mishmash of urban development and eerie desolation. You can enjoy casual wineries and flea markets, yet also encounter abandoned military buildings and a Job Corps campus. It's like stepping into a parallel universe where past, present, and future collide in the most unconventional ways.

I began my adventure at the newly-opened [Ferry Terminal](#) at the foot of the historic Treasure Island Administration Building — once the centerpiece of an old Pan Am airport, which now features Art Deco-style Gold Bar Whiskey Distillery.

Between the historical grandiosity of the building and the tastefully vintage-inspired interior, Gold Bar Distillery feels like somewhere where you would run into someone from the Rat Pack. There are red velvet curtains draped from the ceiling to the floor, gold embellishments throughout the bar area, and details that bring you back to that moment when aviation history was made — even though you weren't actually there.

We chatted with Gold Bar Whiskey's director of marketing, Sam Thumm, who seemed to have a personal relationship with every person who walked in. He showed us around the venue and gave us the lowdown on Gold Bar's partnerships with the San Francisco 49ers — a signal of true cohesiveness with mainland culture.

Gold Bar's menu is whiskey-oriented, but they also do gin, and cocktail flights in case you're as indecisive as I am. They have a full, yet humble kitchen, with dishes inspired by the history of Treasure Island and the building.

Sam says they want to recreate the moment when the building housed the energetic enthusiasm of aviation history in the making, while also satisfying the more modern flavor palette of San Francisco diners.

"The style of travel wasn't what it is today. It was truly a white tablecloth, first-class experience," says Sam.

After Gold Bar, we walked 15 minutes down the coastline to our brunch spot: the bohemian-vibes waterfront restaurant Mersea. The restaurant is housed in shipping containers and borders an open-air whimsically designed garden area. The atmosphere and the staff are relaxed, but it's apparent in the food that there's a lot of tender love, care, and high-quality ingredients put into it.

Executive Chef & Co-Owner Parke Ulrich described his menu as comfort food: "I wanted everything on the menu to evoke your childhood in some way or another."

While I was undeniably comfortable eating a 10/10 breakfast croissant and sneaking bites of my brother's poke bowl, I would be remiss not to mention that Mersea's cuisine is definitely more elevated than any comfort food I've experienced before that day.

After brunch, our server brought over an unsolicited round of the best affogato I've ever had. We indulged while watching The Jaz Force group in the central garden area. They play jazz, R&B, classic rock, and pop music every Friday, Saturday, and Sunday. Between the live music and the Golden Hour bar that Mersea set up in collaboration with Gold Bar Distillery, you could easily pass the whole afternoon here.

While I don't expect the serene nature of the venue to be stripped away anytime soon, it will get more crowded. "The promenade over here will be full of people once some of the developments get underway," Parke nods to the coastline, which sits only 30 feet from our table.

Considering the medley of ultra-tranquil ambiance, SF city skyline views, live entertainment, and top-notch fare, I'm shocked that the hordes of city folk haven't already taken over. It feels like this might finally be my moment to be an early adopter.

**The reinvention of this S.F. island is undergoing its first phase — the rest will take decades**

There’s no stranger slice of San Francisco right now than the one that begins 2 miles northeast of the [Embarcadero](#), on [Treasure Island](#).

Freshly planted shasta daisies and toyon trees line a 22-story luxury high-rise that is almost ready to open, across the street from an empty lot with dirt piled 10 feet high. On the tower’s other side is a condominium project wrapped in scaffolding and, beyond that, a fenced-off job training center for low-income youth.

Another fence lines the nearby shoreline — but that one screens construction crews at work on a 6-acre waterfront park set to open next year.

You get the picture: The reinvention of the 425-acre island created in the 1930s out of rubble and sand to hold the Golden Gate International Exposition is a work in progress that likely will continue for decades. But the first phase is far enough along that if you’re curious about how urban landscapes emerge and mature, this is the summer to start taking notes.

The work completed so far includes three residential buildings and the streetscapes along them, as well as the miniature ferry terminal [that began service in 2022](#). Two six-story market-rate housing complexes are sheathed but fully shaped en route to debuting by next summer, around the same time as the bayside park with dead-on views of San Francisco’s downtown skyline and home-shrouded hills. There also are townhomes and condominiums [tucked into the slopes](#) of adjacent Yerba Buena Island, as well as [Hiroshi Sugimoto’s needle-thin](#) “Point of Infinity” sculpture.

But any large transformation needs a visual hook to alert the public that big changes have arrived. That’s what Treasure Island now has with Isle House, the 250-unit apartment tower designed by David Baker Architects for Wilson Meany and Stockbridge, part of the islands’ master development team.



Baker has made his mark with [inventive low-income housing](#) such as 222 Taylor St. in the Tenderloin, or such [stylish complexes](#) as Hayes Valley's 300 Ivy St. This is the firm's first high-rise, easily viewed from the Embarcadero as a vertical accent to Treasure Island's tabletop terrain.

From this perspective there's not much going on, a tall squat cube with a flat top and a pale skin. It's when you step off the quick ferry from the Ferry Building (where else?) that Isle House's urbane poise comes into focus.

For starters, the simple rectangle isn't so simple: The tower is set apart from a six-story base by a recessed floor clad largely in glass. From there on up, serrated but subtle bays enliven the dimensions without being choppy.

Many architects would do that one twist and call it a day. Baker keeps going.

The bottom two levels are black brick while the rest of the base wears a randomized mix of three shades of gray tiles. Above *that*, Baker shifts to clean white plaster — and arranges that plaster in strong upward strips, rather than punched windows or horizontal bands. The pattern is evocative of the stylish vintage airplane hangars along nearby Clipper Cove, a reminder that historical allusions have a place in contemporary design.

A wholly different approach to Treasure Island's renewal is two blocks to the north at Star View Court, where people this summer began moving into the seven-story structure that holds 138 apartments stacked around a long central courtyard.

Unlike Isle House, which consists almost entirely of market-rate apartments, Star View Court is reserved for low-income residents. This includes 94 that are set aside for households — many of them formerly homeless — who already live on the island in what originally was military housing. Those blocks of suburban-style homes will likely remain for at least the next decade, along with the island's scattering of restaurants among the older buildings.

The emphasis on income diversity is constant in the redevelopment plans, with approximately 2,200 of the eventual 8,000 units to be priced at below-market levels. But the plans also call for a uniform level of building quality, and Star View Court fits seamlessly into the emerging landscape.

Along Seven Seas Avenue, which serves as Treasure Island's main north-south roadway, the building developed by Mercy Housing is a seven-story bar in muted tones of white and gray. On the pedestrian-scaled mid-block alley to the west, heights drop to four stories with porches fanning out along the way. The closest thing to an architectural flourish comes where the two sides meet in a glassy community room that juts out from the second floor — it faces an empty lot that someday will be a park — and is backed by a metal-screened open walkway for residents and their guests.

“With affordable housing you only get a few shots to do something interesting” in terms of design, said Eric Robinson, a principal at Paulett Taggart Architects, the project's designer. “You need to be strategic.”

Put another way: If Isle House is aimed at residents with high discretionary incomes, Star Court adds to the district character not just architecturally, but by providing a good home for people who might have

## **Mystery Clipper Cove Platform Identified As "Float Lab"**

*Earlier this week we received word from concerned boaters about a structure that had mysteriously appeared in the entrance to Clipper Cove. The news began circulating on social media, while we began tracking down the origins and owners of this new kid in the cove. We learned the structure is a float lab operated by San Francisco's Architectural Ecologies Lab. We reached out to the BCDC, USCG, and TISC to learn more, and to Margaret Ikeda and Evan Jones, co-directors of the Architectural Ecologies Lab, California College of the Arts, San Francisco, who sent us the following information about the platform.*

When it comes to quirky floating things, we imagine the boaters of S.F. Bay have very nearly seen it all: old boats and new ones; fast and slow ones; boats that are houses and even houses that are boats. "Google barges" to DIY projects and everything in between. You may have seen another unusual-looking structure floating on the north side of the entrance to Clipper Cove that arrived the first week of August, and in the strong lineage of creative watercraft made of FRP (fiber-reinforced polymers), this structure has an equally compelling story. It is called the Float Lab.

The Float Lab is a floating artificial structure, that, like everything floating, relies on principles of buoyancy, ballast and stability. The electronics, bilge pumps and batteries are typical of boating technology. However, its overall shape, small textures and unique topology depend on advances in parametric modeling, digital fabrication and CNC mold making. The design began with an insight from marine ecologists to turn ocean-fouling communities on the bottom of floating structures into an ecological asset. For boats, fouling creates an unwanted "drag." For structures that don't move, though, the hull can become an upside-down reef. Yet there is little research into the types of communities that can inhabit these underwater surfaces and which types of conditions different marine animals prefer. Questions such as these inspired the collaboration between architectural designers at California College of the Arts (CCA) in San Francisco, marine ecologists from Moss Landing Marine Laboratories (MLML), and a composite manufacturer from American Canyon. Each discipline inspired the others to create a novel form, with unique habitat surfaces, above and below the water.

The Float Lab's first home for five years was in the remote cove of Middle Harbor Shoreline Park (MHSP) in collaboration with the Port of Oakland. Since there had been nothing like this before in the Bay, it took over a year for the Float Lab to be designated under the Department of the Army Nationwide Permit (NWP) 4, for Fish and Wildlife Harvesting, Enhancement, and Attraction Devices and Activities. At MHSP we hung different underwater experiments testing productive fouling, gathered data with sensors, and even captured acoustic data during the pandemic to record the sound in the Bay with very little boat traffic. We put a time-lapse GoPro on top and got a glimpse into the variety of birds that used it to perch, feed, dry off and sleep. We moved it recently to Treasure Island for a few important reasons: to engage with students and the public about ocean ecology, and to have better access to ecological hanging experiments. As with any move, the various applications, permits, allowances and letters of support were onerous, but BCDC approved the application for this specific location in part because of the public access and educational benefits that will accrue inside the cove and with our community partners like TISC. We anchored the Float Lab with the same system recommended by the Port of

Oakland divers: four 9-ft-long helix screw anchors with a 1:4 ratio of water depth to distance to keep the Float Lab at the most stable location.

TISC is excited to engage its participants with the Float Lab, too. Each year TISC gets over 1200 kids from San Francisco Unified School District out on the water for a Science and Sailing lesson in Clipper Cove. We hope these future boaters of S.F. Bay will benefit from the Float Lab's bringing more educational opportunities to TISC and from increased attention to TISC, the cove and the health of the Bay.

Clipper Cove is a fantastic venue for so many different folks who are passionate about Bay access and ocean health. While CCA is excited to do its part by continuing to learn and research ways to make our communities healthier and more resilient, we are also sensitive to the idea that Clipper Cove is a community resource with many kinds of users.

We learned that the sedimentation at the entrance to the cove is a long-term problem that gets worse every year. We were told that in this magazine this has been a frequent topic of conversation for a long time and that it provides tips for getting into and out of the cove, which is getting busier. Days after our move to Treasure Island we learned from some of you [*Latitude* readers] the complication the Float Lab is causing getting into the cove. This was new information to us, so we are actively working on ways to fix this situation. We do not want to be part of the problem; we are hoping to be part of a solution protecting the health of our oceans and providing incredibly unique and place-based educational opportunities for our diverse community of young people in the Bay Area. We hope you get to see the Float Lab next time you visit Clipper Cove.
