The "Hands of Unity" mural, proposed for Elm Alley in San Francisco, celebrates community unity, diversity, and growth. The mural's centerpiece will be a circular motif of colorful, intertwined handprints from the nearby elementary school's art club, symbolizing the neighborhood's vibrant cultures. Surrounding the circle, abstract shapes and patterns will represent the area's diverse influences, while a background gradient from dark to light reflects the community's resilience and transformation over time. This mural aligns with the vision of Elm Alley as a lively, inclusive space for both children and residents.

2. Materials and processes to be used for wall preparation, mural creation and anti-graffiti treatment.

Thorough surface preparation, including power washing to remove dirt and debris, followed by scraping to eliminate loose paint and ensure a clean base. The wall will then be primed with exterior masonry primer for optimal adhesion. The mural will be painted with high-quality exterior house paint, and finally, sealed with a professional-grade anti-graffiti clear coat by This Stuff Works, ensuring long-lasting protection and durability

Lead artist Strider Patton is overseeing the mural's design and execution. He is facilitating several creative workshops with the Tenderloin Elementary School art club and gathering stories and insights from the broader community to inform and inspire the mural's design.



Dear San Francisco Arts Commission:

We are writing to provide some context for the proposed mural project on Elm Street that you are considering here.

From the outset of our efforts to create a safe and healthy child-focused play area on the neglected street adjacent to Tenderloin Community School, the Friends of Elm Alley have defined it as a collective endeavor, sought community input, and worked with multiple city agencies. We wanted it - and knew it needed to be - a shared project.

Our initial implementation was a low-cost pilot to allow for social distancing during drop off and pick up when children returned to school a year into the pandemic. That simple transformation of the alley was well received by students, families, the school and after school programs.

The community's insistence that resulted in TCAP and then their broad support during the participatory budgeting process has moved this project forward and increased its scope.

As part of a growing coalition committed to creating new public outdoor spaces in the neighborhood, we are excited about this collaboration. Art installations on the alley will both dramatically change the space and celebrate our collective work. We appreciate the community's support.

As a condition of the Property Owner's approval and authorization to create the Artwork on the Property, Artist agrees to waive and does hereby waive voluntarily all rights to attribution and integrity with respect to the Artwork and any and all claims as may arise under the Visual Artists Rights Act of 1990, 17 U.S.C. §§106A and 113(d) ("VARA"), the California Art Preservation Act (Cal. Civ. Code §§987 and 989) ("CAPA"), or any other local, state, foreign or international law, as currently drafted or as may be hereafter amended, that conveys the same or similar rights (collectively "Moral Rights Laws"), with respect to the Artwork, its display, removal from display, exhibition, installation, conservation, storage, study, alteration and any other activities conducted by the Property Owner or any future owner of the Property. If the Artwork is incorporated into a building such that the Artwork cannot be removed from the building without physical defacement, mutilation, alternation, distortion, destruction, or other modification (collectively, "Modification") of the Artwork, Artist waives any and all such claims under any Moral Rights Laws arising out of or against any current or future owners of the Property, and its agents, officers and employees, for Modification of the Artwork.

The Property Owner, or any future owner of the Property, has the absolute right to change, modify, destroy, remove, relocate, move, replace, transport, repair or restore the Artwork, in whole or in part without prior notice to the Artist. However, if the Property Owner, or any future owner of the Property, modifies the Artwork without the Artist's consent in a manner that is prejudicial to Artist's reputation, Artist retains the right to disclaim authorship of the Artwork in accordance with 17 U.S.C. § 106A (a) (2).

The Property Owner has no obligation to pursue claims against third parties for modifications or damage to the Artwork done without the Property Owner's authorization. However, the Property Owner may pursue claims against third parties for modifications or damage or to restore the Artwork if the Artwork has been modified without the Property Owner's or Artist's authorization. In the event that the Property Owner pursues such a claim, Property Owner shall notify the Artist, and Artist shall cooperate with the Property Owner's efforts to prosecute such claims.

Artist bears the sole responsibility for providing the San Francisco Arts Commission and Property Owner with any changes to the Artist's Address for Notice. MAINTENANCE PLAN

2024-2025

1 year of initial maintenance included to ensure proper paint adhesion to the surface, including any immediate issues with chosen materials and graffiti/vandalism. Strider Patton will assume responsibility to personally upkeep the mural during this period - implementing monthly site visits and quality control to guarantee longevity of the artwork.

2025-2029

An anti-graffiti protective varnish will be applied (4 coats) to ensure a proper seal of the artwork. Strider Patton will assist in identifying and communicating with a qualified artist or professional to handle any necessary graffiti cleanup or upkeep over the next 5 years.

2030 +

Maintenance of the mural is handed to the responsibility of the building owner.


