I do custom dyeing and repairs as well on customer supplied clothing. I tie dye only high quality brands and stock Carhartt, Dickies, Old Navy and many BOHO brands. I specialize in Overalls (all kinds), Jean Jackets and a vintage Harley Davidson collection along with Hoody's, Tee's, and more. I also do home accessories such as Sheets, Towels, Shower Curtains , Tapestry's, Aprons, Play Tent Teepee's for children and pets and more. I specialize in Ice Dyeing and I achieve maximum saturation that goes beyond other artists work. Most Tie DYE is done with Liquid Dye. I don't use dye that way. I place dye on plant based fabric clothing and then layer ice on top that melts and seeps into the cloth. the dye splits into colors that make that power dye. I also specialize in Vintage Overalls and Jean jackets and do a harley davidson clothing collection. I am size inclusive to size 50/34 and down to child sizes.

I wear Mask, Goggles and gloves to do everything with dye powder. I only open 1 jar at a time and all is wiped down after use. customers only see the finished product. I wash everything in Synthropol with is industrial laundry soap and it removes all remnants of dye or anything else on the cloth. I only use professional Procion dye.
