SPEAKERS: President Lopez acknowledged the victims who were lost 23 years ago on September 11<sup>th</sup>. He further acknowledged the victims' families. He noted that many of the victims were native to San Francisco and the Bay Area and included people who were on Flight 93. He recognized that the people on that flight were considered heroes for reducing the extent of the tragedy of that day.

Commissioner Trasviña thanked President Lopez for his important words. He added that American Airlines flight attendant Betty Ong was on Flight 11 and was the first to communicate to the towers about the horrific situation taking place in the air. Commissioner Trasviña noted that Betty Ong was a graduate of George Washington High School and a proud San Franciscan. He stated that everyone, including her family, was proud of her.
