Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Scott reported on crime trends YTD: Violent Crime down 13 percent; homicide down 42 percent; rape down 12 percent; robbery down 22 percent; assault down 2 percent; human trafficking down 43 percent. Property Crimes down 35 percent; burglary down 13 percent; motor vehicle theft down 18 percent; arson down 12 percent; larceny theft down 42 percent. Gun violence is down 29 percent compared to 2023; Four non-fatal shooting incidents this week; total 97 fire-arm related incidents resulting in 110. victims YTD. One homicide for the week; there are a total of 22 homicides YTD with 17 resulting from a firearm; 86% overall clearance.

Significant Incident: Four non-fatal shootings during this past week, resulting in four victims- one occurred on the 1900 block of Mission, no arrest has been made, witness heard a gunshot as they were walking on the sidewalk and realized that they had been shot, the victim was transported and is in stable condition and has not provided a lot of information, the investigation is ongoing. 9/1/24 15:00, a victim who was unfamiliar with the city advised that he was shot in the area of possibly 6th and Harrison when a vehicle stopped alongside his vehicle, he said the two suspects got out of the vehicle and demanded money, he was punched by one of the suspects, and then the other one fired a round and struck him with the bullet, the victim sought treatment outside the city and then was referred back to SFPD when he told the medical staff that he believes he was shot in San Francisco, that investigation is ongoing, no arrests in that case. Another incident in the unit block of Chicago Street in the Ingleside, victim was or is 11 years old, Officers arrived at the location, victim had a gunshot wound and there was not a whole lot of information as far as who fired that shot, investigation is still ongoing. A collision occurred yesterday, resulted in a fatality, happened at the now closed Cliff House restaurant, involved two vehicles, one of the vehicles had been parked in the area when the second vehicle came around the bend at a high rate of speed and collided with the parked vehicle, both cars went over the cliff and the driver of the parked vehicle sustained non-life threatening injuries, the driver of the other vehicle, the one that came around the bend at a high rate of speed, did not survive the injuries, investigation into this collision is ongoing and is being handled by the Traffic Company. Couple of hate crime incidents over the last couple of weeks, tomorrow there will be a press conference and a rally against hate at the Third Baptist Church led by community members, SFPD will be a part of that, along with other law enforcement agencies and community members, as far as the crimes themselves, they are under investigation and SFPD will investigate these cases vigorously and bring these suspects to justice on these cases.

Significant arrest: Incident that happened over the weekend, attempted robbery and shooting of 49ers player Ricky Pearsall, brief summary of the shooting, happened about 15:37, on Saturday, on Geary in Union Square, Mr. Pearsall was walking alone when he was approached by the suspect, suspect attempted to rob him, a struggle ensued after the suspect pointed a gun, several shots were fired, Mr. Pearsall and the suspect, who turned out to be a 17 year old, were both shot, Officers assigned to the Union Square Detail heard the shots, they were about a block or half a block away, got there within a minute and began to render aid and put out the information about the crime and the suspect description, other officers responded within another minute, and they were able to locate and the suspect and detain him, Officers were right there as the suspect tried to run away, Mr. Pearsall had some serious injuries, but he has been released from the hospital, the suspect, a juvenile, has also been released, the case has been filed by the district attorney, several felony counts have been filed and the case is now in the hands of the juvenile court, even though charges have been filed the investigation is ongoing. Homicide over the weekend, a stabbing with a suspect that was taken into custody, the victim and the suspect were related, although the suspect is in custody, it is still an open investigation, believe the charges were filed in that case today. Several significant arrests while Commission was out – ran retail blitz operations, dozens of arrests have been made with these retail blitz operations. And for the public, blitz operations are when officers are put in plain clothes in retail establishments, if they observe a theft or shoplift, they take action when the person leaves the store and they make arrests, have made hundreds of those arrests over the past year. Ingleside Officer developed a shoplifting and retail theft abatement operation in the 3300 block of Mission, the 800 block of Market, the 5200 block of Diamond Heights and the 2300 block of 16th Street, those areas were chosen due to the high number of shoplifting incidents that businesses were experiencing, between 5/13/24 and 7/29/24, a total of 61 people arrested, including one who was booked for robbery, one who was arrested for second degree burglary and grand theft, and also a probation violation, nine of these individuals had outstanding warrants, so charges were already pending and 52 others were cited and released for theft related charges, which were misdemeanor Charges, stolen property was recovered and returned to the businesses in those operations.

Strategies: There are several events this week and ongoing this weekend. Chinatown night out was today, Commissioner Yee attended that along with SFPD and the Central Station Captain and Officers, a very well attended event, 10th annual event. Oracle Park, Giants playing this week and SFPD is deployed for that. Chase Center, concerts on the 6th and 8th, deployed for that. A 5th anniversary block party on the 8th, SFPD will be deployed for that. DMACC work, that work is ongoing with still arresting a lot of narcotics sellers, enforcement on people using in open. Partnership with DPH is really blossomed, DPH now has a program where they have medical doctors on call 16 hours a day, and for people who are suffering substance abuse disorders, when the navigators or officers refer them to the doctors, they call, they can get basically a prescription for medication to deal with their addiction, a very, very successful program, have been doing the program for two to three months, plan to expand it this month and again next month, it's been a very popular program, and it's a resource in terms of the partnership, something that provides a service that is very, very helpful to hopefully drive down some overdoses and overdose deaths.

Outstanding Issues: DPA's Policy division completed a review of DGO 5.20 Language Access Services for Limited English Proficient Persons with a specific focus on U.S. Department of Justice identified best practices and Settlement Agreements with other jurisdictions
