**Yerba Buena Island Hillcrest Road Improvement Project Breaks Ground**

The [San Francisco County Transportation Authority](#), in partnership with the Treasure Island Development Authority, Caltrans and the Bay Area Toll Authority announced the start of construction on the Hillcrest Road Improvement Project with a groundbreaking ceremony on Thursday September 19th.

The nearly \$38 million project, expected to be completed by 2027, is funded by state and local grants and rebuilds Hillcrest Road to be more resilient, consistent with modern design standards and safer for all travelers, particularly by creating a dedicated multi-use path for people biking and walking. Funding sources include the Infill Infrastructure Grant (a state grant to the Treasure Island Development Authority from Housing and Community Development), Proposition K Local Sales Tax (administered by the Transportation Authority), SB 1 Local Partnership Program Formulaic Program funds (programmed by the California Transportation Commission), and Treasure Island Development Authority.

"The new roadway provides a much improved connection between the West Side Bridges Project and the Southgate Road Interchange Improvement Project as well as with the Bay Trail via the San Francisco-Oakland Bay Bridge," said Transportation Authority Board Chair and District 8 Supervisor Rafael Mandelman. "Thank you to all of our funding and project delivery



partners for their support in creating a safer, more multi-modal Hillcrest Road for the growing neighborhoods on Yerba Buena and Treasure Islands."

Led by the Transportation Authority, the Hillcrest Road Improvement Project will upgrade the roadway to modern roadway and seismic standards and provide additional space for pedestrians and bicyclists traveling between the Islands and east span of the Bay Bridge. The project enables construction of a future multi-use path for active transportation users, anticipated to be delivered through the Bay Skyway phase 1 transbay project linking West Oakland to Treasure Island.

The project features:

- Improved resilience and safety for roadway infrastructure built to modern highway design standards for travelers of all modes
- A new roadway for two vehicular travel lanes, shoulders and space for a future multi-use path
- Two retaining walls (with drainage and art) set further into the hillside above Hillcrest Road to support the new roadway and multimodal facilities
- Accommodation for the future Yerba Buena Island Multi-Use Pathway Project, which is a future 1.2 mile, two-way Class 1 Multi-Use Pathway (MUP) that will extend from the Bay Bridge East Span bicycle/pedestrian landing on Yerba Buena Island to the Treasure Island Ferry Terminal. The future MUP is an essential element of the regional Bay Skyway project that will provide seamless bicycle and pedestrian access from West Oakland to San Francisco.

Project's benefits:

- Improved West Side Bridges and Southgate Road connection
- Improved local and regional connectivity for travelers of all modes
- Improved seismic safety for the project's retaining wall and roadbed that will accommodate the upcoming 1.2 mile Multi-Use Pathway project
- Supporting infrastructure for the growing neighborhoods and economic development of Treasure Island and Yerba Buena Island
- Support for San Francisco's economic recovery through creating and maintaining almost 500 well-paying jobs

"This project marks an important milestone in the development of Yerba Buena Island, improving safety and access for travelers of all modes," said Treasure Island Mobility Management Agency Chair and District 6 Supervisor Matt Dorsey. "Hillcrest Road will enable tens of thousands of additional trips to and from the Island each day serving local residents, businesses, and visitors."

The project is the fifth partnership project among federal, state, regional and local agencies who previously collaborated to deliver:

- I-80/Yerba Buena Island East Side Ramps Project (Opened October 2016)
- I-80/Yerba Buena Vista Point Lookout (Opened May 2017)
- I-80/Yerba Buena Southgate Road/Interchange Project (Opened May 2023)

- I-80/Yerba Buena West Side Bridges Project (underway, completion anticipated in 2026)

## **City of San Francisco and National Women's Soccer Franchise Bay FC Announce Plans for Permanent Training Facility on Treasure Island**

Mayor London N. Breed and [Bay FC](#), the new women's professional soccer franchise representing the Bay Area in the National Women's Soccer League (NWSL), announced today at a joint press conference the plans for the location of Bay FC's new permanent training facility on Treasure Island. The franchise considered dozens of locations in the last year before signing a letter of intent with San Francisco.

The new training facility builds on the redevelopment efforts already underway and overseen by the Treasure Island Development Authority within the City Administrator's Office, and the master developer Treasure Island Community Development, led by Wilson Meany.

Both Treasure Island and Yerba Buena Island are being transformed into an environmentally sustainable new 21st-century San Francisco neighborhoods, in the middle of San Francisco Bay, to include 8,000 new homes of which 2,200 will be affordable units, 300 acres of parks, trails and open spaces, with new restaurants and shops, and public art installations.

"We are proud to welcome Bay FC to be a part of Treasure Island and San Francisco," said Mayor London Breed. "Bay FC is bringing a whole new level of excitement not just to soccer in the Bay Area, but to women's sports. This also is another major success for Treasure Island, a future neighborhood that will be home to thousands of people, thriving businesses, iconic views, and now a new soccer destination that will bring together our professional players and community from across the Bay Area."

The training facility will be privately financed and expand and accelerate Treasure Island's development and the sports programming already planned for further redevelopment of the island. The initial plans include three core training fields and sporting facilities on eight and a half acres of the 40 acres already earmarked for sports use. The remaining land earmarked for sports use will continue to be utilized by those already using it for youth sports.

Built and created specifically for women athletes, Bay FC's world-class training facility will be one of a few purpose-built training facilities for women's sports in the United States and home to Bay FC's players, coaches, and football operations staff. Bay FC's facility will be designed to complement the existing and planned youth recreational facilities on the island and further enhance it as a youth sports destination for soccer clinics, additional community activities, and more for the entire Bay Area.

"Treasure Island provides us an iconic location to continue to build an iconic club – it centers the Bay's team literally in the middle of the Bay," said Bay FC CEO Brady Stewart. "Having a permanent dedicated space that is built specifically for our players and football operations staff

will allow us to continue to attract the best national and international talent and continue our Club's mission of being a catalyst for innovation and change for our athletes and the community. I want to thank the City and County of San Francisco and the Office of Economic and Workforce Development, in addition to the Treasure Island Development Authority in helping to get us to this point."

### More About Mayor Breed's Work to Transform Treasure Island

At 8,000 total units, Treasure Island represents a tenth of the City's housing production goals. The project has made significant progress in the last number of years towards the completion of the first stage of construction - nearly 1,000 homes are open or near completion, along with parks and utilities, public art, new streets, and ferry service.

Currently in the first stage of redevelopment, there are nearly 1,000 homes now open or near completion, with new parks, world-class public art, ferry service, new streets, and by 2025, approximately 1,208 market-rate and affordable housing units will be completed, including 307 affordable units, 788 rental units and 420 condominiums, such as:

- Completed: The Bristol, 124 market rate with inclusionary affordable condominiums on Yerba Buena Island (40% sold)
- Completed: Maceo May Apartments, 105 affordable rental units for homeless and formerly homeless veterans on Treasure Island (fully occupied)
- Completed: The Townhomes and Flats on Yerba Buena Island (sales starting this spring)
- Completed: Star View Court, 138 units of affordable housing by Catholic Charities on Treasure Island
- Completed: Isle House, 250 rental apartments with 24 inclusionary units (leasing starting in June 2024)
- Under construction: 490 Ave. of the Palms, 148 condominiums on Treasure Island
- Under construction: Hawkins, 178 rental apartments on Treasure Island

A package of Mayor Breed's legislation co-sponsored by Supervisors Matt Dorsey and Rafael Mandelman to amend and update the Treasure Island/Yerba Buena Island project agreements were unanimously approved by the Board of Supervisors and signed into law in May of this year. The key element of the legislation was a fiscal measure to accelerate public revenue into the project to enable Stage 2, the next major development phase, to proceed without delay. The legislation makes a number of updates to the project agreements to modernize and improve processes without reducing the community benefits package.

Bay FC plans to break ground on the state-of-the-art facility in 2025 and operate out of the facility in its 2027 season, pending final approval of the San Francisco Board of Supervisors, and will continue to play its regular season matches at PayPal Park in San Jose. Groundbreaking, and more announcements regarding the training center will come in 2025.

### **Bay FC won't say if stadium follows 'heart and soul' to SF**

Bay FC CEO Brady Stewart said the professional women's soccer team's "heart and soul" will be in San Francisco when the club's new Treasure Island training facility is completed in 2027 — but it remains to be seen whether its future stadium will be, too.

The Bay Area's highest-level women's soccer club, which said Tuesday it would begin construction in 2025 on a privately financed practice center at Treasure Island, remained mum on where it is seeking to build a permanent playing field. Bay FC, which is chasing a playoff spot in its [inaugural National Women's Soccer League season](#), agreed to play for five years at San Jose's PayPal Park, home of Major League Soccer's Earthquakes.

When The Examiner asked whether the decision to build a training facility will have any impact on where the team chooses to build a new stadium, Stewart was tight-lipped.

"Our priority right now is getting this training facility done because it is the most important element of our athletes' experience," she said. "In terms of a stadium, we're a team for the full Bay Area, for all nine counties of the bay. When we think about our stadium, we'll consider the full bay in our exploration."

The club's players currently practice at San Jose State University. Stewart said most of them currently live in San Jose, which is about 50 miles away from Treasure Island.

But Bay FC's business offices are already in The City. The Treasure Island facility will house three soccer pitches, a locker room, weight room, recovery room, video room and offices for the team's sporting operations.

"It will be no less than the heart and soul of the club," Stewart said.

Mayor London Breed joined several high-ranking Bay FC executives — including Stewart and U.S. soccer legend and club co-owner Brandi Chastain — to announce the facility in a ceremony on the seventh floor of Isle House Apartments, a 22-story waterfront tower overlooking the San Francisco skyline.

The training facility will be built on a 8.5-acre plot of land a few blocks behind the apartment complex on top of what is now a large hill of dirt partially marked with a blue Bay FC banner.

"Treasure Island is one of the newest, hippest, coolest neighborhoods that is happening right before our eyes, and we couldn't be more thrilled to welcome Bay FC to Treasure Island as their new home for their training facility," Breed said amid swirling winds on the building's balcony. "This is going to be extraordinary."

But it's still unclear whether or not the training facility will have any bearing on where the team will build its permanent stadium.

Bay FC's [five-season lease at PayPal Park](#) would conclude at the end of the 2028 season. Assuming the training facility opens on time in 2027 and the team does not break its agreement to play in San Jose, that would leave at least one season in which players would have to commute between the South Bay and The City for games and training, respectively.

Stewart said the NWSL does have parameters restricting how far a team's stadium can be from its training facility. However, all nine Bay Area counties fit within those requirements relative to Treasure Island. She maintained that all nine Bay Area counties remain on the table for the site of a new stadium.

The Examiner reported a year ago that [The City had met not only with](#) an architecture firm it commissioned to conduct a feasibility assessment on a soccer stadium near Union Square, but also Sixth Street Partners — the primary investment firm backing Bay FC — before Breed publicly [floated the possibility](#) last summer of a San Francisco soccer stadium at the current site of Emporium Centre San Francisco. The San Francisco Standard had previously obtained the stadium renderings.

On Tuesday, Breed and Supervisor Matt Dorsey — whose district includes Treasure Island — were both outwardly hopeful that Bay FC would choose San Francisco for its new stadium, while neither revealed where discussion currently stood.

"I'm keeping my fingers crossed for the future of where their final stadium will be," Breed said. "But it has to be at close proximity to wherever the practice field is, so who knows what might happen?"

"As the mayor said, there's going to be some decisions made about where that stadium may be and you can bet that I'm going to be fighting hard to make sure that's a downtown stadium in my district," Dorsey said, which drew applause from Breed.

Stewart touted that the site will be one of the few training facilities in the world dedicated solely to a professional women's soccer team.

"We will be a world-class destination both for the players of Bay FC, our current players and as we continue to attract and bring in national and international talent here to the Bay," she said.

Chastain, a Bay Area native and member of the U.S. Soccer Hall of Fame, had to pause briefly at the start of her remarks to gather herself emotionally, recalling that as a little girl in the community she did not have many female role models to look up to.

"Our game of soccer is unique — it came to the U.S. as a non-traditional sport, and it speaks every language and it embraces every community," Chastain said. "We feel that that is why being here on Treasure Island makes perfect sense, because we will [speak to every community](#), and we will play the game in a way that everybody feels welcome. Our space will be open for



teams to come from around the world to see this beautiful community that we live in, to share in all of its delights and its bright, shiny gems and the beauty of the bridges that surround it.”

## **Bay FC soccer club to build training facility on San Francisco's Treasure Island**

Bay FC, the Bay Area's National Women's Soccer League team, announced plans on Tuesday to build a training facility on Treasure Island in San Francisco Bay.

The team said the eight-acre training facility will feature a 20,000-square-foot clubhouse and three practice fields. Construction will begin in 2025 and the facility has a scheduled opening in 2027. The facility is designed to complement existing and planned youth recreational activities on the island, Bay FC said.

At a press conference Tuesday morning at Treasure Island with Bay FC executives and city officials, San Francisco Mayor London Breed hailed the project as another success for the burgeoning island neighborhood.

"This is so incredible to see women's sports take it to the next level and to see people get so excited," said Breed. "This is not necessarily where legends are born this is where legends will be made."

San Jose native Brandi Chastain is co-founder of Bay FC and someone who is forever etched in sports history with her iconic celebration clinching Team USA's World Cup in 1999.

"We didn't see other women playing team sports in big stadiums, so we made this out of nothing," said Chastain.

The announcement comes as infrastructure around the island continues to expand.

Developers said 1,800 of the 8,000 planned homes have been completed, as city leaders tout its growth.

"It is laying the foundation for what Treasure Island will be where there's housing, office space, sports and entertainment and restaurants, parks and open space," said San Francisco Mayor London Breed.

Isle House, a 250-apartment structure which opened this month, is where the team made the announcement.

Brady Stewart is CEO of Bay FC. She doesn't know how many players or staff will choose to live on the island in the coming years, but it's becoming a more viable option.

"We want them to have a lot of living options. That's one of the great strengths of Treasure Island, is the location for us," said Stewart.

Nearly 300 acres of parkland are also in the works. Several public parks have opened recently, in a district some are calling a 'new mini-city'.

"I love it that every time I'm here there's some new building that's up and a new place to go. This is a really happening place. People are going to start noticing this is a great place to be," said District 6 Supervisor Matt Dorsey.

For Chastain, Bay FC's new home is also a growing opportunity to inspire a younger generation of soccer players.

"You have to be brave, proactive, and courageous. That's really what I think Bay FC's underlying story is really about," said Chastain.

The project won't have any public funding involved.

Bay FC currently practices at San Jose State University and [plays home games at PayPal Park](#), sharing the space with the San Jose Earthquakes. The team says it's happy with the current arrangement but will eventually want its own stadium.

The facility plans are pending approval of a lease from the city's Treasure Island Development Authority and the Board of Supervisors.

Beautiful bonus: Its Golden Hour bar serves whiskeys distilled right on the island from [Gold Bar Whiskey](#).

You can take the ferry to get to Mersea (it's a 15 minute walk from the ferry terminal) if you don't want to drive, or take the bus or rideshare. Besides the dog-friendly ranking, Mersea is also ranked as #1 out of 4,917 San Francisco restaurants on the platform and has a full five-dot ranking. Sounds like we need to make a trip out with our frisky Jack Russell.
