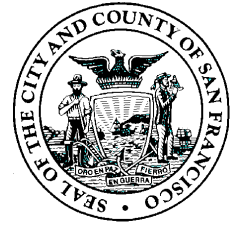

Proposition Q (1988), "The Community Health Care Planning Ordinance", Appendix 17 of the San Francisco Administrative Code, requires hospitals in San Francisco to provide public notice prior to closing a hospital inpatient or outpatient facility, eliminating or reducing the level of services provided, or leasing, selling, or transfer of management. The Health Commission is required to hold public hearings in which the Commission shall make findings based on evidence and testimony and any submitted material that the proposed action will or will not have a detrimental impact on health care services in the community. **The Health Commission does not have authority to change the outcome of the proposed closure.** This is the first of two hearings on this item. The Commission is scheduled to vote on this issue at its November 5, 2024 meeting.
