### Fine Arts Museums of San Francisco Board of Trustees Tuesday, May 29, 2024 3:00 pm

#### Call to Order

A regular meeting of the Fine Arts Museums of San Francisco Board of Trustees was held on Tuesday, May 29, 2024. The meeting was called to order at 3:02 p.m. by Diane B. Wilsey, Chair Emerita.

Director and CEO Thomas P. Campbell read the Fine Arts Museums FAMSF and Legion of Honor Land Acknowledgment - Revised as of May 2023:

The Fine Arts Museums of San Francisco occupy unceded land of the Ramaytush Ohlone, who are the original inhabitants of what is now the San Francisco Peninsula. The greater Bay Area is also the ancestral territory of other Ohlone peoples, as well as the Miwok, Yokuts, and Patwin. We acknowledge, recognize, and honor the Indigenous ancestors, elders, and descendants whose nations and communities have lived in the Bay Area over many generations and continue to do so today. We respect the enduring relationships that exist between Indigenous peoples and their homelands. We are committed to partnering with Indigenous communities to raise awareness of their legacy and engage with the history of this region and the impacts of genocide and the dynamics of settler colonialism that persist.

Lincoln Park, where the Legion of Honor was founded in 1924, operated as City Cemetery from 1868 until 1898. When the park was created, many of the burials were relocated but the majority were not. Please join the Fine Arts Museums of San Francisco in honoring the memory of the thousands of individuals still buried on this land.

### **Report of the Acquisitions Committee – Thomas P. Campbell on behalf of William R. Hearst III, Fine Arts Museums Foundation Acquisitions Committee Chair**

Mr. Campbell reviewed the report of the May 9, 2024 Acquisitions Committee that included 4 purchases, 4 funded purchases, 15 gifts, 12 first step deaccessions, and 12 second step deaccessions. The full report of May 9 Acquisitions Committee is attached as Appendix I.

On motion, duly seconded, the Board approved the May 9 2024 report, accepting the purchases, gifts and deaccessions. There was no discussion among the Trustees and there was no public comment.

### **Report of the Director and CEO – Thomas P. Campbell, Director and CEO**

Mr. Campbell began by thanking trustees for their energy and support over past year, and noted the importance of the letter that trustees sent to the Mayor and Board of Supervisors in support of maintaining FAMSF's funding. In the coming fiscal year, with a stable budget, we will be able to maintain the standards of excellence and accessibility for the community in our exhibitions and collection initiatives, and in our wide-ranging educational programming.

Exhibitions program review:

- *Lee Ming Wei, Rituals of Care*  
This survey presentation of Tawainese artist Lee Mingwei's work continues through July 7 at the de Young. Final performance of his entrancing work, Sonic Blossom will take place on Thurs–Fri, June 27–28 and Sat–Sun, June 29–30.
- *Irving Penn*  
Over 175 photographs from genre-defying photographer Irving Penn's seven decade career are currently on view in the de Young's Herbst galleries through July 21
- Our collection exhibition, *From the Floating World to the Modern World: Japanese Prints in Transition* is on view through August 18 at the Legion of Honor. Featuring works from the Achenbach Foundation for Graphic Arts that haven't been displayed for a more than a decade,

this two-part exhibition (the floating world and the modern world) highlights this stylistic transition and the work of one artist, Tsukioka Yoshitoshi, who successfully spanned them both

Upcoming Exhibitions:

- In June *Leilah Babirye: We Have a History*—which will be the artist’s first solo exhibition in the US, will open at the de Young. Born in Kampala, Uganda, and based in New York, Babirye is known for her highly expressive, ambiguously gendered sculptures in ceramic, wood, and discarded objects.
- *About Place* at the de Young will be the second in an exhibition series celebrating a generous donation from the Svane Family Foundation, *About Place: Bay Area Artists from the Svane Gift* explores how ten Bay Area artists see themselves in relation to their environments by considering notions of place as physical land, heritage, a site for the imaginary, or belonging.
- Set to open in October at the Legion, *Mary Cassatt at Work* will be a major attraction. Often described as a sentimental painter of mothers and children, Mary Cassatt was in fact a bold modernist pioneer: a fiercely professional artist, a committed member of the French Impressionist movement, an aesthetically radical painter, pastelist, and printmaker.
- In October we will also debut a major retrospective of art deco star *Tamara de Lempicka’s* captivating work at the de Young. The first exhibition of its kind on Lempicka organized in the United States, this exhibition will bring together nearly 100 of the artist’s masterpieces. This exhibition will travel to the Museum of Fine Arts, Houston.
- *Art and War in the Renaissance: The Battle of Pavia Tapestries* opens on October 19 at the de Young

Free Saturdays

- FAMSF’s signature Free Saturdays program recently celebrated its five year anniversary; since its launch, this program has benefitted over half a million people, making the museums more accessible to our local communities.

Education Update

- FAMSF’s education offerings of wide-ranging education programs served 303,136 participants
  - This number encompasses access offerings, lectures, more inclusive interpretation offerings, docent tours, audio guide, and Vitality Arts for seniors. This number is markedly higher than our engagement numbers from the previous fiscal year due to the popularity of the *Kehinde Wiley* programs.
- Consistent with FAMSF’s commitment to serving both SFUSD students and San Francisco youth, the Equity School Partnership Program engages schools that traditionally have not visited the Museums.

FURTHER RESOLVED, That the funds in Project 10023196 are to be used to reimburse the Corporation of the Fine Arts Museums for expenses incurred on behalf of the Museums.
