I. CALL TO ORDER: DISCUSSION

President Sophia Andary called the meeting to order at 5:03pm.

Dr. Joseph Macaluso performed roll call and confirmed 5 of 7 Commissioners present (quorum). Dr. Macaluso read the land acknowledgement.

II. APPROVAL OF MINUTES: DISCUSSION and ACTION

The Commission reviewed and approved the minutes from the regular Commission meeting on August 21, 2024, with a correction to the spelling of Commissioner Diane Jones Lowrey's name on Page 2.

III. DIRECTOR'S REPORT: DISCUSSION

Director Ellis gave a brief highlight of the Director's Report, which included the launch of the new DOSW website. The new site is user-friendly and reflects the Department's commitment to making sure women, girls and non-binary individuals have access to resources and information to support gender equity.

As part of the Department's Bay Area Abortion Rights Coalition (BAARC) initiative, on September 17, the Department published the regional abortion landscape report titled *Preparing for An Uncertain Future in Post-Dobbs America: A Landscape Analysis of Abortion Care in the San Francisco Bay Area.*

The Department and Clarity Research group completed the 2024 Community Needs Assessment, which asked individuals working, living or going to school in San Francisco about their experiences here. We exceeded our target of 700 survey responses, receiving more than 1000 responses. Clarity Research Group will share a draft of the findings with the department in late October.

B. PRESENTATION FROM LEAGUE OF WOMEN VOTERS SF: DISCUSSION

The League of Women Voters of San Francisco President, Alison Goh, discussed the organization's background, current initiatives, and topics related to the upcoming election. She explained how LWVSF encourages voter registration and education, specifically among women, Gen Z, millennials, and nonbinary individuals. She highlighted the hosting of 11 candidate forums, 66 Candidate Statements, and 48 Speakers Bureau presentations this election cycle, along with the distribution of ballot measure information.

Additionally, Alison Goh discussed the LWVSF Youth Council, and their project called VR'ing Democracy, which walks users through a virtual voting booth in multiple languages, introduces people to the voting process with an aim to reduce stress and empower voters.

Commissioner Comment:

Commissioner Diane Jones Lowrey was very impressed by an LWVSF event the previous week, and wished there were more people in attendance to communicate with candidates. She mentioned that the Pros & Cons Guide is 1 of 3 guides her husband uses to vote, as it is very balanced and informational.

Commissioner Ani Rivera asked if there is a DEI Strategy. LWVSF President Goh replied that DE&I is included in bylaws, though they must continue to improve and reach more people, especially those not currently represented.

President Andary said she would love to see the VR program integrated with VR headsets. LWVSF President Goh replied that they are working on this idea.

President Andary thanked the League of Women Voters, noting that LWVSF was educating on redistricting before most people understood the practice and ramifications, especially those against our most marginalized communities. She encouraged people to look at the fine print, who is funding propositions, and to push for transparency, civilian oversight, and accountability.
