1) CALL TO ORDER

3) COMMUNITY HEALTH EQUITY AND PROMOTION BRANCH (CHEP)

Nyisha Underwood, MPH CHEP Director, presented the item.

Commissioner Comments:

Commissioner Christian thanked Ms. Underwood for the impactful work. She asked how the safety home assessments come about for seniors. Christina Goetta, Deputy Director of Community Wellness, stated that referrals come through social workers and health fairs.
