Highlights for October 9, 2024

The following report includes the Department of Police Accountability's recent developments:

- ◆ The **Audit Division** is finalizing the draft of the stop data audit. Our goal is to have an exit conference with SFPD this month.
- ◆ DPA sent our Chief of Investigations, Director of Mediation, and a Senior Investigator to conduct outreach with the 283 Recruit Class at the academy.

Investigation Updates

- ◆ **Cases Opened/Closed:** Our office opened 14 new cases and closed 31 cases since the last Commission meeting.
- ◆ **Allegation Trends:** The top allegation this week remained officers behaving or speaking inappropriately (Conduct Unbecoming).

Conduct Unbecoming	The officer behaved or spoke inappropriately.	17%
Unwarranted Action	The officer engaged in unwarranted action.	13%
Neglect of Duty	The officer failed to take required action.	13%
Neglect of Duty	Fail to properly investigate	13%
Use of Force	The officer used unnecessary or excessive force	9%
