DCYF's RFP Planning Process



- Mayor Breed's Juvenile Justice Reform Blue Ribbon Panel (2019): Recommended building a comprehensive and system-wide reform that stressed the importance of effective service coordination, collaboration, and delivery through healing-centered approaches; the process included gathering feedback from community and systems stakeholders.
- Close Juvenile Hall Working Group (2019): San Francisco Board of Supervisors voted to close down the Juvenile Hall and created a taskforce to propose alternatives to the traditional facility.
- DJJ Realignment Subcommittee (2021) As mandated by SB 823, which closed the Division of Juvenile Justice (DJJ), this subcommittee of the Juvenile Justice Coordinating Council developed San Francisco's DJJ Realignment Plan for providing care to youth who would have previously been committed to state youth prison. This public process included city agencies, community organizations, formerly juvenile justice involved adults, and members of the public.
- Community Needs Assessment (2022): First phase of DCYF planning cycle that deeply engages children, youth, TAY/A, and their families to understand their current strengths and challenges while ensuring that their voices are represented throughout the planning process.
- Services Allocation Plan (2023): Second phase of the DCYF planning cycle that articulated DCYF's strategic plan for addressing the needs and disparities highlighted in the CNA; describes the service areas and partnerships we intend to support and allocates resources to them.
- DCYF worked jointly with Justice Partners to create Request for Funding Proposals strategies in Justice Services
 (2023): RFP is the last phase of DCYF planning cycle. The RFP was released October 2023, decisions announced
 April 2024. Will be a 5-year funding cycle, 2024-2029, programming will begin July 1st.

- ► The Human Rights Commission (HRC), established in 1964, addresses the causes of and problems resulting from prejudice, intolerance, bigotry, and discrimination.
- ► The Civil Rights Division enforces local antidiscrimination ordinances and ensures compliance by contractors in housing, employment, and public accommodation settings.
- ► Civil Rights Division work includes protected classes under all federal and state of California laws, as well as protections unique to San Francisco.

FAIR CHANCE ORDINANCE

- Procedural Requirements:
 - Criminal history information cannot be requested or considered until the applicant has been found to be eligible for housing or employment
 - ► Applicants/tenants must be given notice about the FCO and an opportunity to respond to information that shows up on a background check
 - ► Applicants must be assessed on an individual basis:
 - ► No blanket bans for criminal history

For complaints related to housing and criminal history, you will want to contact the Civil Rights Division at SFHRC, for complaints related to employment, you will want to contact the Office of Labor Standards Enforcement (OLSE)

- Application or advertisement states "we don't rent to anyone with a felony"
- Housing application form asks about criminal history
- ► Housing provider rejects an application due to criminal history information, without conducting an individualized assessment
- Housing provider rejects an application due to criminal history information, without giving the applicant sufficient notice and an opportunity to respond
- Housing provider rejects an application because of a conviction that occurred more than 7 years ago

EXAMPLES OF FCO VIOLATIONS IN HOUSING

PROPOSED LANGUAGE CHANGES

- Add protected categories of criminal history that cannot be considered, this would include protecting individuals for the following activities that are legal in California but illegal in other states:
- Abortion related healthcare
- ▶ Gender affirming care
- Drag performances
