Concrete platform and guardrail to host informational plaques memorializing the Irish Great Famine at Lincoln Park. The platform will be 320-sqft in size. The foundation footing will be set along the northern perimeter of the platform at a maximum15-ft depth. Additional piles will be installed up to 12-ft depths along the perimeter of the platform. The entrance to the platform will be set at a ~2-ft depth into the hillside.
