This letter conveys the results of the Citywide Fiscal and Compliance Monitoring conducted for FY23-24. The monitoring was led by Wasim Samara, Department of Public Health in conjunction with other funding City Departments.

The fiscal and compliance monitoring reviewed multiple standards, including but not limited to the following categories: Agency-Wide Budget, Audited Financial Statements, Financial Reports and Invoice Review.

Overall Assessment

In general, Community Forward San Francisco meets most of the financial stability standards of the City. It's change in unrestricted net assets (net income) hovers around break-even over the years, with most of the years having a small surplus. Its cash flow from operations is also positive over the years. The agency did make some investments in property and equipment that resulted in their cash reserves dipping below the 30 days mark.
