#### ARTIST BIO: Jess Tse "Letter J"

Jess is a queer Asian American creative currently residing and working in East Oakland by way of San Francisco where she was born and raised. Her work is inspired by the many facets of her life, largely including her adoration for printed goods, packaging, and ephemera found rummaging through estate sales and antique stores. Her obsession over vintage comics and illustrations, typography, and hand painted signage all play a heavy influence on her style of work. Though a lot of her work is finished digitally, all of her work is hand-drawn.

Jess has extensive experience working directly with friends, clients, and collaborators of all backgrounds, especially from her experience co-founding & co-running a design studio under the moniker OpenDaily. During that period of time (2018-2021), she led branding projects, art directed campaigns, project managed, & produced events. She is currently working on a large indoor mural for a local small business opening up soon on Geary Blvd., which will be her first opportunity spearheading a project of this scale. Additionally, she has assisted on 2 murals with Brooklyn-based artist, Amanda Phingbodhipakkiya, in San Carlos and Jack London.

Given the opportunity to execute this parklet mural installation for Spicy Shrimp, Jess would take her time in fully engaging in the experience in order to get to know the community in which her art aims to serve. Her goal as a creative is to connect with her community by creating dialogue through her work, whether through food, visual art, merchandise, or immersive experiences.












Figure 2 Mural Assistant to Amanda Phingbodhipakkiya in San Carlos (2020)

Code §§987 and 989 )("CAPA"), or any other local, state, foreign or international law, as currently drafted or as may be hereafter amended, that conveys the same or similar rights (collectively "Moral Rights Laws"), with respect to the Artwork, its display, removal from display, exhibition, installation, conservation, storage, study, alteration and any other activities conducted by the Property Owner or any future owner of the Property. If the Artwork is incorporated into a building such that the Artwork cannot be removed from the building without physical defacement, mutilation, alternation, distortion, destruction, or other modification (collectively, "Modification") of the Artwork, Artist waives any and all such claims under any Moral Rights Laws arising out of or against any current or future owners of the Property, and its agents, officers and employees, for Modification of the Artwork.

The Property Owner, or any future owner of the Property, has the absolute right to change, modify, destroy, remove, relocate, move, replace, transport, repair or restore the Artwork, in whole or in part without prior notice to the Artist. However, if the Property Owner, or any future owner of the Property, modifies the Artwork without the Artist's consent in a manner that is prejudicial to Artist's reputation, Artist retains the right to disclaim authorship of the Artwork in accordance with 17 U.S.C. § 106A (a) (2).

The Property Owner has no obligation to pursue claims against third parties for modifications or damage to the Artwork done without the Property Owner's authorization. However, the Property Owner may pursue claims against third parties for modifications or damage or to restore the Artwork if the Artwork has been modified without the Property Owner's or Artist's authorization. In the event that the Property Owner pursues such a claim, Property Owner shall notify the Artist, and Artist shall cooperate with the Property Owner's efforts to prosecute such claims.

Artist bears the sole responsibility for providing the San Francisco Arts Commission and Property Owner with any changes to the Artist's Address for Notice.
