



## JH 1.2: Average & Peak Population (slide 7)




### JH 4.1: Admissions by % Mandatory (slide 17)

# JH 3.1: Average Length of Stay for Detained Youth Released (slide 14)


Length of Stay (in Days) for Detained Youth Released Throughout the Month by Month



Note: As of the April-24 report, the calculation of length of stay has been updated to reflect only detained youth released.


Average length of stay for committed youth released will be reported on in annual reports due to small Ns.

### AB12 AFTER: Smart Money Coaching Program

Transformation Update

- AB12 participants who owe victim restitution and would have been eligible for the AFTER program are referred to **Smart Money Coaching**, offered through a Treasurer's Office contract with Financial Capability Investment.
- Once AB12 participants complete 4 sessions of financial literacy coaching, their victim restitution is paid and the restitution order is closed. This benefits both the young person and the victim.
- The Treasurer's Office has philanthropic funding to cover the cost of the restitution payment. JPD issues the restitution payment to the named victim.
- JPD pays for the Smart Money Coaching sessions.
- In the first quarter of 2024, 16 (sixteen) AB12 participants received Smart Money Coaching!

### Foundations for the Future: Guaranteed Income Pilot Program

Transformation Update

- GI Pilot has reached enrollment goal!
  - 150 former San Francisco foster youth have been enrolled in the Guaranteed Income
     (GI) Pilot Program.
  - 50 JPD youth (out of 57 eligible youth)
- Eligibility Requirements
  - At least 21 years old and have aged out of San Francisco extended foster care through Family & Children's Services or Juvenile Probation, on or after January 1, 2022.
  - Have an annual household income of \$60,000 or less for a single adult (no children).
- San Francisco is 1 of 7 pilot sites across the state.
- GI Pilot participants receive \$1,200 per month of unrestricted funds for 18 months.
