On September 25, 2024, this Item was rescheduled from October 9, 2024 to October 30, 2024, given that there would not be a quorum for this case on October 9, 2024 (President Lopez would be absent and Commissioner Eppler would be required to recuse himself from hearing the matter).

ACTION: Upon motion by Vice President Trasviña, the Board voted 2-1-1 (Commissioner Swig dissented and Commissioner Eppler recused) to continue the Item to November 13, 2024, so that the parties can continue negotiating on this matter.

SPEAKERS: Commissioner Eppler disclosed that he is the President of the Potrero Boosters Neighborhood Association, one of the appellants, and therefore he recused himself from the hearing discussion and the vote on the continuance.
