## Resident Engagement:

**In November, TI Advisors conducted 10 scheduled one-on-one sessions, they received over 20 direct calls to the TI phone, and many additional TI Advisor engagement calls, emails, and other communications.** This number of scheduled sessions is lower than in previous months, given that most transition units have been filled and households receiving a second round of move notices quickly transitioned. Most calls were focused primarily on scheduling moves and completing payment processing for in-lieu payments.

**TI Advisors attended the November In-Person Board Meeting on November 13th to continue engaging residents on the Hawkins application.** They held an informational tabling session before the meeting kickoff in partnership with the Hawkins management team. During the tabling session, a handful of residents stopped by to ask questions about the upcoming Hawkins application process and to walk through their qualifications, allowing us to provide additional information and address their concerns directly.

**The team conducted strategic outreach for Hawkins in November.** TI Advisors sent an email blast and distributed door hangers to all households in the Villages upon the launch of the application to ensure residents were well-informed. Following this, TI Advisors sent out another email blast before the



application deadline as a reminder. They made individual phone calls to households to ensure interested residents submitted their applications by the 5 pm deadline on November 26th.

**TI Advisors processed 10 of in-lieu claims this month, including move allowance payments and in-lieu payments for residents relocating off the Island or to a BMR unit.** Our team worked hard to simplify the process for residents. The team met residents wherever they were—on the Island or at their new homes—to complete paperwork and deliver payments in person. By making these efforts, TI Advisors hope to ease the burden of this challenging transition and support residents in every way possible.

**For households facing unique challenges, TI Advisors assisted in granting extensions for their move.** This flexibility allowed residents with particular circumstances to have additional time for their relocation to ensure a smooth transition into their new homes.

## Monthly Summary

In November, TI Advisors continued supporting households as they applied for or transitioned to new housing opportunities, including units at Isle House, applications for Hawkins, and off-Island locations. TI Advisors engaged with over 7 households to begin the application for Hawkins.

**Similar to last month, TI Advisors have focused on closing the loop on all transition units at Star View Cour units. Currently, all units, except three three-bedroom units, are occupied.** Any available, affordable units have been offered to households on the DAHLIA waitlist. TI Advisors have actively encouraged households to apply for upcoming housing opportunities, introducing residents to the possibilities of IC4.3 and the senior housing building and helping them consider their future options.

To prepare for the Hawkins application period, TI Advisors were available to quickly answer questions about TIR numbers and income qualifications for the building.

Overall, this month, TI Advisors' efforts focused on coordinating moves, delivering in-lieu payments, and providing information about new housing opportunities. TI Advisors continue offering one-on-one support to make the relocation process as smooth and supportive as possible.

One TI continues to serve an average of 200 households. One TI will host a holiday celebration at the pantry on 12/17 from 3-5 PM. We will distribute ham and turkeys, gingerbread houses and toys in partnership with the YMCA.

- **facilitated staff training for island businesses** by providing an understanding of Treasure Island history and aspects of its current revitalization.



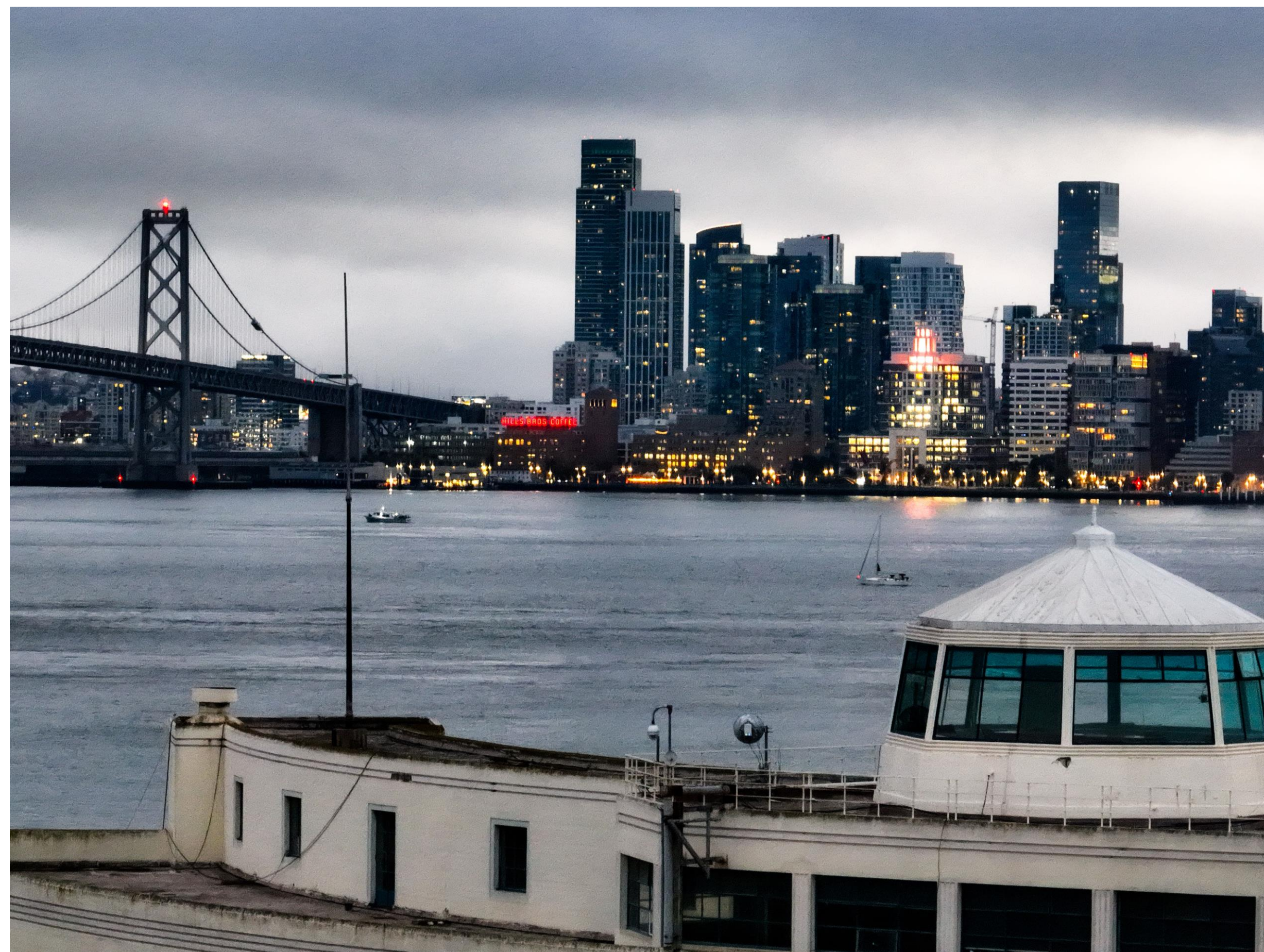
