4. Director's Report

Director Arntz presented his November 2024 report, mainly focused on preand post-election activities. He reported and increased number of poll workers for this election; confirmed a high voter turnout in San Francisco and that positive voter experiences were reported at polling places. The election night operation was well-organized and calm, with a productive energy. There were no notable poll place incidents. Director Arntz indicated the Department was still in the process of curing ballots and was on track to certifying the election on/by December 5, 2024.

Commissioners shared accolades regarding the Department's facilitation of the election and related activities, media reporting, efforts to educate voters about ranked choice voting, and the new results reporting visuals and graphics.

President Stone suggested the Commission should monitor feedback regarding the new policy of listing proponents and opponents on the ballot.

There were no public commenters.

5. Commissioners' Report

Vice President Parker as well as President Stone reported on their separate visits to the Pier 31 elections warehouse on Election Day and both observed very well-organized and efficient ballot processing. Commissioner Dai performed a poll site review, including taking photos, and remarked on positive voter experience. Commissioner Wong visited multiple poll sites and remarked on the proactive language access and efforts to increase registration and participation in senior housing.
