Governing Documents/Background:


- Disposition and Development Agreement (Treasure Island/Yerba Buena Island) ("DDA") executed 2011
- Jobs and Equal Opportunity Program ("Jobs EOP") was an Exhibit to the DDA
- Jobs EOP establishes small business policies and participation goals for Covered Work
- Jobs EOP requires Authority to establish reporting and monitoring procedures for small business goals ("SBE Procedures")

Small Business Procedures:

- Small Business Participation Goals
 - 41% Construction Contracts
 - > 38% Professional Services Contracts
 - First consideration for San Francisco based SBEs
- Certified by CMD, OCII or TIDA for San Francisco businesses
- Certified by TIDA or CA Department of General Services for non-San Francisco businesses
- > TIDA SBE Certification: Gross receipts <\$24M for construction services, <\$5M professional services last 3 year
- SBEs cannot subcontract out more than 50% of scope to a non-SBE

Stage 1 Overview

- TICD Stage 1 geotechnical improvements and infrastructure complete
- 3 out of 8 market-rate buildings in Stage 1 complete
- 2 out of 2 100% affordable buildings complete
 - Not governed by Treasure
 Island/Yerba Buena Island Small
 Business Procedures



Process Improvements

- TIDA involvement early in process
 - Scopes identified before bidding and shared in advance for TIDA to track
- Outreach improvements
 - CMD support
 - Email list from TIDA
 - Contact every LBE in CMD's database with every scope
 - Additional email solicitation and calls to ensure participation
- Pre-bid meetings/job-walks prior to all RFPs
 - > Including: SBE Information, scope details, schedule, prequalification process, site walk
- Standardized reporting for each contract
- Launched LBE/SBE Mentorship Program for Treasure Island & Yerba Buena Island


Treasure Island Development Authority

- Stage 2 Demo, Cut-Cap, Geotechnical Work: Building Demolition and Abatement, Surface Demo, Utility Demo, Trucking/Hauling, Waste Disposal, Debris Hauling, Vibro-compation and Tamping, Surcharge Placement, Deep Soil Mixing
 - Work anticipated Q2 2025 through 2028
- Stage 2 Street Improvements: Wet-Utilities (sewer, storm drain, water), Dry Utilities, Roadway Streetscape (paving, striping), Landscape, Pump Stations, Surveying, Maintenance
 - Work anticipated Q2 2025 through 2028
- Clipper Cove Promenade: Concrete, Trucking, Electrical, Wet-Utilities (sewer, storm drain, water), Final Clean Landscape, Paving, Surveying, Maintenance
 - Work anticipated Q2 2025 through 2026
- Chapel: Demo, Landscape/Irrigation, Site Work & Concrete, Glazing, Metal Framing/Drywall/Taping, Painting, Flooring, HVAC, Electrical

 - Work anticipated Q2 2025 through 2026










