## Fiscal Year 24-25 Finance Update

- 50% (6 months) of the fiscal year has elapsed.
- To date, DBI has collected 56% of FY25 budgeted Charges for Services revenue.

### Year-end projections:

- Based on actuals collected for the first six months, total year end revenues are projected to be \$69.2M, \$1.4M
   (2%) above budget. Total year end expenditures are projected to at budget.
- To date, DBI salary and fringe budget is 46% spent. Total year end salary and fringe expenditures are projected to be on budget pending guidance from the Mayor's Office regarding the hiring freeze announced 1/9/25.
