

## APPLICATION FOR REPORT OF RESIDENTIAL BUILDING RECORD

HOUSING CODE, SECTION 351(a)

IT SHALL BE UNLAWFUL FOR THE OWNER OF SUCH RESIDENTIAL BUILDING TO SELL OR EXCHANGE SAME WITHOUT FIRST HAVING OBTAINED AND DELIVERED TO THE BUYER THE REPORT OF RESIDENTIAL BUILDING RECORD HEREIN PROVIDED FOR. A RESIDENTIAL BUILDING IS DEFINED AS A BUILDING OR PORTION THEREOF CONTAINING ONE OR MORE DWELLING UNITS BUT NOT INCLUDING HOTELS CONTAINING 30 OR MORE GUEST ROOMS, OR MOTELS

- A. The fee is \$171.12 for each report requested. We accept cash, Visa & Master Card, check and/or money order (made payable to City & County of San Francisco Department of Building Inspection or CCSF-DBI). Payer's name must be printed on the check. Write the requested address on the check. There will be NO REFUND or CANCELLATION once request and payment have been received.
- B. EACH residential building on a given LOT requires a separateapplication and payment.
