

Vaccinating those at higher risk

Beginning March 15, eligibility for vaccination in San Francisco will be extended to individuals aged 16-64 who are at the highest risk of getting very sick from COVID-19 as a direct result of one or more of the following qualifying conditions:

1 Health conditions

- Cancer, active
- Chronic kidney disease
- Severe chronic pulmonary disease, including COPD and those who are oxygen dependent
- Down syndrome
- Immune compromise from blood, bone marrow, or solid organ transplant; immune deficiencies; HIV; use of corticosteroids; or use of other immune weakening medicines
- Pregnancy
- Sickle cell disease
- Heart conditions, such as heart failure, coronary artery disease, or cardiomyopathies (excludes hypertension)
- Obesity (BMI>30 kg/m2)
- Diabetes

Disabilities

Including those which are developmental, medical, physical, sensory, or behavioral health, including severe mental health and/or substance abuse disorders.

3 High risk settings

Experiencing homelessness, or live or work in a high-risk congregate care facility including correctional facilities, homeless shelters, and other congregate residential care/treatment facilities.

How do I prove I'm high risk and eligible?

You may bring documentation if you have it, however, self-attestation is the only requirement.

COST: Vaccines are **free** to people who live and work in San Francisco.

INSURANCE: You do **not** need insurance to book an appointmentment.

Book your COVID-19 Appointment

Getting vaccinated will help keep you, your family, and your community safe and healthy. **COST:** Vaccines are **free** to people who live and work in San Francisco.

INSURANCE: You do **not** need insurance to book an appointment.

- If you have limited internet access, need assistance, or cannot travel to a vaccination site because of a disability, call the City hotline at (628) 652-2700 for help with booking options. This hotline is prioritized for people ages 65 and older and people with disabilities.
- In addition to larger vaccine sites, there are many neighborhood locations which may change or be added depending on need. All changes to vaccine sites are updated on the website so check back frequently.
- Check each vaccine site to see if there are appointments available.
- Supply is limited, and you may not be able to book an appointment right away. Keep checking back.

Book an appointment

Book an appointment online at sf.gov/GetVaccinated

You will need the following information:

- Name
- Address
- Date of birth
- Insurance

If using the state's MyTurn website to book an appointment, follow the above criteria for high risk conditions, disabilities, and high risk settings rather than the state's criteria, which may be less expansive.

Accessibility

Check transportation options and accessibility for the vaccine site before you go.

Muni and Paratransit are free for anyone traveling to and from COVID-19 vaccine appointments. SFMTA is also providing additional access to taxi service for those using the Essential Trip Card.

Most walk-thru sites have drop-off zones and are fully wheelchair accessible.

- If wheelchair assistance is needed, just ask on-site staff and a wheelchair will be brought out to you.
- Site ambassadors will gladly direct you once on site.
