1. SUMMARY. What major changes is the department proposing? Include a description of changes intended to improve core service delivery. The law library does not propose any major spending changes, and has not asked the city to fund new positions or programs for decades, in order to keep city costs down. It has no appropriation for legal materials, databases and the full staff the Library requires. These functions are funded by a portion of civil court filing fees, pursuant to state law. COVID impacts on filing fee income required the Library to lay-off three non-CCSF funded staff, which necessitated the small remaining staff to absorb the work of the laid off employees as well as their own duties. This has been and continues to be a challenge for the Law Library. We will need to fill full-time position 0190 which we held off on doing the last two years to provide the city savings.
2. TARGET. How did the department meet its General Fund cost neutral target?	The Law Library met the General Fund cost neutral target & proided one-time cost savings by holding off on filling one of its three full-time Charter mandated positions, 0190.



1C BUDGET EQUITY

1. What is the department's approach to advancing racial equity in the services provided to the residents of San Francisco?

It is the mission of the San Francisco Law Library to provide all citizens of San Francisco free access and use of legal materials in order that they may conduct their legal affairs and preserve their legal rights. The San Francisco Law Library strives to provide a welcoming space where patrons from any background and level of education can come to gain an understanding of the legal system and participate in justice. We understand the American legal system is complicated and we strive to bridge the justice gap by providing professional reference services, legal materials, and educational programs in a variety of literacy levels and formats. In addition to in-person legal resources and reference services, we offer a variety of remote resources and services including access to self-help legal databases, virtual reference services, and virtual educational programs. We partner with local legal services to connect patrons with free and low-cost legal services. We coordinate programs with City partners to educate the public on topics including elections, landlord/tenant issues, immigration rights, racial justice, and bail reform. The law library provides a safe space where all San Franciscans can learn to participate in democracy and justice.

2. What are the department's top racial equity priorities for the upcoming budget cycle? Are there any existing programs that the department is proposing or recommending new initiatives in order to fulfill racial equity priorities?

During COVID the law library shifted all legal education programs and legal services clinics to a virtual format for safety reasons. Our priorities for the coming budget cycle include reestablishing in-house programs and clinics with our legal services and community partners. We also look forward to greater outreach to affinity groups within the San Francisco Bar Association and legal services community to expand our reach to more diverse groups and patrons. We also plan to expand our outreach through neighborhood community organizations and newspapers to increase awareness of the law library.


