Hi, my name is Emily Murase, a former school board member and served 5 mayors as head of the City's Department on the Status of Women. I am the new Executive Director of the Japantown Task Force as of this past week, succeeding the mighty Steve Nakajo. I am also on the board of the San Francisco Chapter of the Japanese American Citizens League. I have been involved with Japantown all my life. My kids are graduates of Rosa Parks Elementary School.

You may know that, before the war, there were over 80 Japanese and Japanese American communities across the country, at least 40 in California alone. Today, San Francisco Japantown is just one of three remaining communities. The others are San Jose Japantown and Little Tokyo in Los Angeles.

Let me be clear: government policies are responsible for the destruction of Japanese American communities, including the wartime incarceration and Redevelopment. In both cases, Japanese American families and businesses were forcibly removed and largely uncompensated, impoverishing not only families and businesses, but entire communities, for decades.

The borders of Japantown have been well-established in two documents adopted by the San Francisco Planning Department and the Board of Supervisors.

According to these maps, the Booker T. Washington Service Center, the Japanese Community Youth Council, the Buddhist Church, the Buchanan YMCA, and Rosa Parks Elementary School

We ask you to

1. maintain the Japantown borders adopted by the Planning Commission and the Board of Supervisors.
2. maintain the historical and physical connection with the Western Addition and Fillmore District, especially the Black communities.
3. Keep these communities intact and in District 5.

Good morning Chair Townsend and honorable members of the S.F. Redistricting Taskforce -

My name is Shakirah Simley, I am a daughter of Harlem, now an adopted daughter of the Harlem of the West. I have proudly called San Francisco home for 14 years and have lived and worked in the Western Addition/Fillmore for over a decade. I come to you proudly as a young Black woman, a first-time homeowner in the Western Addition, now, as the Executive Director of San Francisco's oldest Black-led and Black-serving organization, the Booker T. Washington Community Service Center.

I **love** this community with all my heart and we **MUST** at all costs, protect and preserve the needs, homes, businesses and institutions of the Black community **as a community of interest** in District 5. We must reject any gerrymandering that will dilute or destroy the voices and representation of our Black community. And we must hold firm the legacy that our elders and ancestors warriors built before us to maintain this a thriving and united legal and civil Black foothold in the heart of San Francisco.

What does this mean? That means to the south - preserving the affordable homes of Black seniors and families at Hayes Valley North and South, and recognizing the Black queer history along Hayes and Octavia Blvd; at the center - protecting the anchor institutions, African American Art and Culture Complex and Ella Hill Hutch Community Center, and Black-owned businesses all along our merchant corridors of Fillmore Street, Haight Street and along Divisadero. To the east - saving the last bastion of Black homeownership and cooperative housing at Freedom West homes along Gough. To the north - keeping intact the culture and heritage of Japantown on BOTH sides of Geary.

It also means the most western stretches of D5, and protecting Booker T. Community Service Center and Westside Courts.

We have yet to atone for the decades of policy violence that has drastically shaped this community. From redevelopment and government-led forced removal that led to veritable cultural and economic genocide of the Black AND Japanese American community, to the ensuing years of gentrification, and current housing affordability crisis and public health pandemic that has fallen deeply along racial lines. I'm sick and tired of good white intentions or political football that have led to disastrous Black outcomes. A reparative and just approach to redistricting D5 means centering the needs of those most harmed, and uplifting the solutions from & by the Black community.

We've been here before. Since 1919, Booker T. has been a beacon of support and light for our Black/ African-Americans and in solidarity with our Japantown community. We been at 800 Presidio Ave between Sutter and Lyon **for 70 years**. We are located two blocks away from the historic Westside Courts which was the City's first public housing development, the first to accept Black folks, and has sustained Black families for almost 5 generations.

The Center has seen many a fight in its day. Booker T. was unfortunately placed in District 2 after the 2000 Census which effectively marginalized our voice **and** those served out of the Center who were constituents of District 5. A racist and classist battle with our nearby neighbors went all the way to the California Court of Appeals almost prevented the building of 5 stories of affordable housing for foster youth and low-income families. It took a heroic coalition neighbors, schools and community organizations to save this affordable housing, and the work of then D5 Supervisor Breed to keep the Center in its rightful home.

Booker T is a beautiful 72,000 sq ft cultural center that continues to provide affordable housing, childcare, recreation, educational, and workforce opportunities, COVID-19 support and family stabilization to thousands of D5 residents every year. We know where we are wanted and needed. Our Center and Westside Courts must stay in District 5.

Our lives matter and are not puzzle pieces to fit political ambitions of those who do know, or care about our community. Hold firm the lines. Respect our history. Protect our future.

Dear members of the Redistricting Task Force,

We are a coalition of community organizations representing working-class and immigrant communities of color in San Francisco. **We are writing to you today to strongly urge the Task Force to release a city-wide district draft map by mid-to-late February.**

We understand that members of the Task Force have expressed wanting to meet with community members from all districts before starting the map drawing process. We commend your commitment to hearing input from the community before making any big decisions. However, as the schedule stands, the Task Force won't meet with all districts until March 14th, leaving less than four weeks to draw maps, get input on those maps, adjust the boundaries as you hear input, and create, decide on, and submit a final map. Looking at neighboring jurisdictions who have released draft maps 3-4 months prior to their deadline and still struggled to hear input from the community and/or missed their deadline, this is simply not a realistic timeline.

For this reason, we propose that the Redistricting Task Force meets with two districts per meeting instead of one or add more meetings to speed up the timeline of talking with people in every district. Members of the Task Force, the mapping consultant, Q2, and members of the public have all voiced support for this proposal. For the few members of the Task Force who have voiced concerns over not giving each district a full meeting dedicated just to them, nothing has to change from the way the district-focused meetings were planned. Each district can, and should, get their own agenda item and time slot. The only difference is that there would be an additional district on the agenda, but members of each district should still receive your full attention and their own time to speak to the concerns and communities of interest of their district.

If the Redistricting Task Force doesn't find some way to shorten their timeline, create a deadline and plan to release draft maps by mid-to-late February, and schedule community listening sessions to receive input on those draft maps, we fear that it will not be possible to truly do this process justice by giving people ample time to give feedback on the draft maps. This will risk shutting out members of the community who cannot make last minute schedule changes to make these meetings or write in within a small window of time and further alienate those who already find this process inaccessible and uninviting.

Please double up on districts per meeting or add more meetings, release a draft map by mid-to-late February, and give San Franciscans the time and space they deserve to give input on the changes that will impact their communities for the next decade.

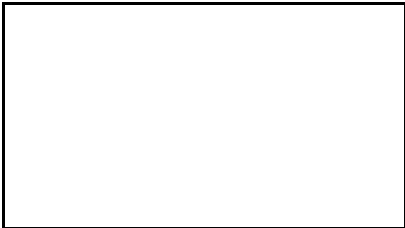
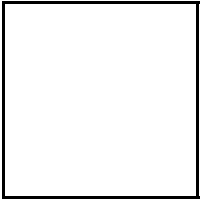

I am a resident of 43 Emerson St. between Masonic and Geary in the Laurel Heights neighborhood.

I was shocked to learn that redistricting potentially would remove Laurel Heights, my neighborhood, from Supervisorial District 2 and **I am writing to request that Laurel Heights remain in Supervisorial District 2**, which has been the case for many, many years. I am 65 years old, and 43 Emerson St. is my family home. My parents bought their home in 1953. There are eleven families on the block, three of them that I have known my entire life. This is my extended family.

My neighborhood has a strong Community of Interest with the other D2 neighborhoods, including Jordan Park, Cow Hollow, the Marina, Presidio and Pacific Heights. Our neighborhoods have collaborated on social, cultural, and economic issues and projects over the years, including with respect to public safety, housing for the homeless, and regarding major housing developments that impact all the neighborhoods listed above that form our collective Community of Interest. Removing Laurel Heights from District 2 would splinter and sever our Community of Interest. I, along with my neighborhood, have formed a strong bond and productive working relationships with the public organizations within District 2, especially with our Supervisor Catherine Stefani, for whom those of us active in Laurel Heights have all shown great collective support, and we do not wish to see these bonds severed or disrupted.
