To Whom It May Concern:

My name is Jennifer Doan and I have worked in the Veritable Vegetable community, located in the Dogpatch neighborhood (District 10) for 5 years. I'd like you to keep my community together in the new district maps.

Veritable Vegetable is an organic produce distributor servicing wholesale customers throughout California, Nevada, Arizona, New Mexico, Colorado and Hawaii. We have been in operation for 46 years, based in San Francisco for our entire existence and located in the Dogpatch neighborhood for the last 37 years. We are a San Francisco Legacy Business, certified San Francisco Green Business and certified B Corporation. Our community consists largely of the 115 employees that work at Veritable Vegetable, and to a greater extent, the vendors and farms we partner with and the customers we sell to.

We are a values-based company and consider ourselves a social enterprise. We believe in building a sustainable food system to preserve the environment and the vitality of farmers and the communities we serve. Many of the individuals and businesses in our community share these values.

The staff that work at Veritable Vegetable represent a diverse group from a wide range of ethnicities and socio-economic backgrounds. Many languages are spoken within our community including Spanish, French, German, Mandarin, Tagalog, Ukrainian, Vietnamese and more. Our staff reside throughout San Francisco and the greater Bay Area.

Issues that impact the Veritable Vegetable community include: changes to parking regulations in the neighborhood, changes or disruptions to public transportation (SFMTA, MUNI, BART), and the increased prevalence of the homeless population and encampments near our warehouses.

Veritable Vegetable is physically located in 3 warehouses between 25th street and Tulare Street to the North and South and Indiana and Tennessee Street, East to West. We are walking distance to the T Line on the Muni on 3rd Street.

Veritable Vegetable represents the industrial sector surrounded by residential neighborhoods. We are similar to some parts of the Bayview and any other neighborhood with industrial warehouses. However, we are different from most other neighborhoods in San Francisco. Even within our own neighborhood in District 10, we are different. Much of the Dogpatch is residential—individuals who live in the area or small businesses that serve the residential community.

We are a 24/7 business; we have staff working 7 days a week and all hours of the day. Changes to transportation lines such as service ending early or reduced frequency affects whether or not someone can get to work on time or return home at the end of their shift. Increased homeless encampments near our warehouses have raised a number of safety concerns. We've had staff assaulted in broad daylight when walking between our buildings, unstable persons trespassing inside our warehouses, damage to property, and hazardous materials left outside our buildings. RVs park in front of our building for extended periods of time, which makes it challenging for our staff to find street parking when they arrive at work.

We appreciate it when feedback is solicited prior to any infrastructure changes in the neighborhood such as when the SFMTA asked for our input prior to implementing new parking restrictions in the Dogpatch.

I'm writing to express my **strong opposition to *any* redistricting proposals** that would:

- Move the Diamond Heights neighborhood out of district 8 (generally the Castro, Noe Valley, Twin Peaks, and Duboce Triangle neighborhoods) OR
- Split the Diamond Heights neighborhood between districts

As I'm sure the Redistricting Commission is aware, "districts must respect the boundaries of... neighborhoods and communities of Interest, and minimize their division, to the extent possible."

I have been a member of the Diamond Heights neighborhood since I moved here in 2010, up from the Castro. I am also a proud member of the LGBTQ community, and Diamond Heights has always felt naturally connected to both the Twin Peaks and Castro neighborhoods, largely by the community of folks (who represent deep communities of both shared-experience and trauma and mutual support and aid, the very definition of "community of interest") within each of those neighborhoods and who spend much of their professional and personal time among those neighborhoods. One of the reasons I moved to Diamond Heights was, in fact, because it felt so familiar to the Castro neighborhood I originally moved to SF to live in. (A friend and his husband were instrumental in extolling the virtues of Diamond Heights.)

I have many friends who live in both of the Castro and Twin Peaks neighborhoods and the goings-on within District 8, the decisions our Supervisor is facing and must vote on, and the general condition of the public facilities of District 8 are all common topics at happy hours, holidays, and town halls my friends and chosen family show up for. Many social and support services utilized by myself and my friends and chosen family are provided by organizations based in the heart of the Castro.

I run into my Noe Valley and Twin Peaks neighbors, friends, and chosen family when they come up to the Diamond Heights Shopping Center to check their PO boxes and grab a couple groceries at the ("Secret!") Safeway.

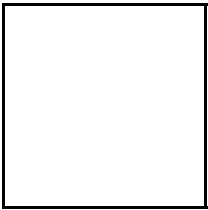
