

Many do not know that it also includes the largest proportion of residents that speak Tagalog and the largest concentration of Filipinos in San Francisco.





Dear Commissioners,

My name is Marily Mondejar, CEO of the Filipina Women's Network, and a long term resident of San Francisco since 1981. I was a former commissioner in the 2012 San Francisco Redistricting Task Force appointed by the late Mayor Ed Lee. I also served as president for three years, vice president for two years, and three years as commissioner of the Commission on Community Investment and Infrastructure (OCII), the former San Francisco Redevelopment Agency appointed by Mayor Ed Lee.

I write to appeal to the San Francisco Redistricting Task Force to keep the Filipino Community in District 11 intact. The Filipino Communities of Interest in D11 have been developed through the years to serve the unique and ethnic needs of the community as well as our allies and neighbors - Chinese, Latinx, African American, and other multi-racial communities.

The Filipino community has suffered evictions and displacements from D3 and D6 and over 12,000 Filipinos have found a home in D11.

FILIPINO COMMUNITY NARRATIVE:

- Filipino families historically have been displaced from the Manilatown community around Kearny and Jackson Streets, a community that thrived from the 1920s to the late 1970s.
- More than 1,00 residents lived tin Manilatown plus about 30,000 transient laborers and farmworkers in the agriculture, fishing, construction, and shipyard industries.
- The Filipinos were gradually evicted by the SF Redevelopment Agency headed by Justin Herman to make room for the growth of the financial district, known as "urban renewal.".
- The final straw was the I-Hotel midnight eviction by 400 riot police led by Sheriff Richard Hongisto on August 4, 1977. This is considered by historians as "the most offensive action by authorities in San Francisco history."
- Filipinos, a resilient community, then migrated to the Yerba Buena area and SOMA in D6 as the significant hub of Filipino culture, activism, and community.
- Again, the SF Redevelopment Agency displaced 4,000 Filipinos to make way for the construction of the Yerba Buena Gardens complex, the Moscone Convention Center, museums, and luxury hotels.
- Starting in the 1970s, Filipino families began to migrate to D11 in search of affordable, single-family houses. They found affordable housing and built their lives in the D11 area to improve their future, raise their multi-generational families and put down roots
- The Filipinos developed services to suit the needs of Filipino families, opening restaurants, small groceries and farmers' markets. Dentists, opticians, and barbers opened clinics and storefronts.
- The Filipino immigrants grew up in D11, went to local schools, churches, and parks

with other multicultural residents which make up the rich diversity of D11 - Excelsior, Crocker Amazon, Ingleside, Outer Mission, Oceanview, Merced Heights neighborhoods.

• The Filipinos lobbied City Hall for accessibility to transportation and social services for seniors and after-school programs for the youth.

Now that the Filipino families have established roots, do NOT split the community. Please keep our community together. The Communities of Interest map shows the many businesses and nonprofits, community centers, churches, markets, parks, schools and transportation hubs that are critical to families. The Filipinos have been displaced numerous times. **Allow us to live in peace.** Protect and preserve the Filipino, Asian, Latinx, African American communities and other minority groups in D11.



These totals show the average, and deviation from the average, or variance, in voter registration, voter turnout, and percentage turnout at the District level. There is further variance at the Neighborhood and Precinct levels, which means that voter registration and turnout is not consistent, or homogeneous, within each District; neighborhoods and precincts with higher registration, turnout, and percentage turnout have disproportional voting power compared to neighborhoods and precincts with lower registration, turnout, and percentage turnout, within each District. 
It has come to my attention that you are considering making changes to district maps which directly involve my neighborhood/location within SF.



What is your community of interest?

My community of interest is known as The Potrero. It includes Potrero Hill, the Design District, Dogpatch, and the Third Street Corridor, extending to the Central Waterfront.

If you take a tour of our community, you will note the many turn-of-the-century homes, historical nightlife venues, and light industrial warehouses dating back to the 1906 earthquake. But, you'll also be struck by the sheer number of new multi family apartment complexes, office spaces, and creative businesses— development largely driven by UCSF and a biotech hub to our North East.

Because of the rapid pace of change, residents have a unified voice in preserving the essential character of The Potrero, expressed through groups such as the Dogpatch Neighborhood Association and the Potrero Hill Boosters. In 2015 the community even established the city's first community benefit district devoted to carving out healthy green spaces in the public realm—the Dogpatch NW Potrero Hill Green Benefit District.

Our neighborhoods also have another huge challenge—that is, highways 101 and 280. The 101 has exits at Cesar Chavez, Vermont Street, and Seventh Street. The 280 has exits at Mariposa, 6th Streets, and King Street. Heavy traffic from large commercial vehicles as well as commuter cars must use this infrastructure to enter San Francisco. The easy entry and "getaway" provides the perfect opportunity to commit crimes in the City and flee at high speeds on our streets. Additionally, freeway overpasses promote illegal dumping and encampments, as well as the attendant sanitation and fire hazards.

Where is it located?

The Potrero Hill / Dogpatch COI is roughly bounded by Cesar Chavez Street, Potrero Avenue, Division Street, 7th Street, 16th Street, and the Bay.

Why should it be kept together?

The Potrero should be kept together in a single district so that it can continue to advocate, with the help of one supervisor, for responsible development. In regard to the blight caused by freeway infrastructure, we need one supervisor who can navigate the complexities of working with San Francisco social services as well as Caltrans and CA Highway Patrol to mitigate the impacts on residents.






