1. Call to Order and Roll Call

The Redistricting Task Force met in special session, in-person with remote access and public comment via telephone and videoconference, on Monday, April 4, 2022. Chair Reverend Arnold Townsend called the meeting to order at 5:42 p.m.

On the call of the roll, Chair Townsend, Member Jeremy Lee, Member Hernández Gil, Member Pierce, Member Castillon, Member Ho, Member Cooper, Member Chasel Lee, and Vice Chair Reiner were noted present.

A quorum was present.

2. Mapping

Member Chasel Lee provided a presentation on mapping and public input, including an overview of the redistricting process, important criteria for redistricting, recognized neighborhoods and communities of interest, compactness, contiguity, census geography, and the next steps for the Task Force. Jaime Clark, Redistricting Consultant (Q2 Data and Research); Andrew Shen, Deputy City Attorney (Office of the City Attorney); answered questions raised throughout the discussion.

Chair Townsend recessed the meeting beginning at 8:33 p.m., and reconvened the meeting at 8:52 p.m.

At the request of Chair Townsend, Vice Chair Reiner assumed the Chair pro tem at 11:49 p.m., and resumed the Chair at 11:54 p.m.

Speakers: Walter Caplan; requested that the Task Force recognize the Lakeshore Acres and Merced Manor neighborhoods and retain them wholly within District 7 rather than District 4.

Christine Zaback; shared various concerns with the Task Force in regard to the Districts 4 and 7 boundaries.

Cheryl Thornton; requested that the Task Force retain Potrero Hill in District 10. Martha Bolden; requested that the Task Force include the Seacliff and Presidio Heights neighborhoods in District 2 rather than District 1.

Margaret Cooley; requested that the Task Force include the Seacliff and Presidio Terrace neighborhoods in District 2 rather than District 1.

Julie Pitta; requested that the Task Force include the Seacliff and Presidio Terrace neighborhoods in District 2 rather than District 1, and requested that the Task Force expand the eastern boundary of District 1 toward Anza Vista.

Naj Daniels; requested that the Task Force recognize the area of Potrero Avenue, 16th Street to the bay waterfront, Highway 101, Mansell Avenue to Bayshore Avenue, Geneva Avenue, Potrero Hill, Bayview Hunters Point, and Sunnydale as a community of interest and retain it wholly within District 10.

- Add the Lower Polk Community Benefit District to District 3;
- Add portions of the Cathedral Hill neighborhood to District 2, with boundaries of Pine Street, Van Ness Avenue, Post Street, Franklin Street, and Gough Street;
- Add the northern waterfront north of Bay Street to District 2;
- Add portions of the Russian Hill neighborhood to District 3, with boundaries on Van Ness Avenue north of Union Street and south of Bay Street;
- Add portions of the Cathedral Hill neighborhood to District 2, with boundaries on Ellis Street, Gough Street, and Van Ness Avenue;
- Add areas north of Columbus Avenue to the bay waterfront to District 3.
- Add the area bounded by Van Ness Avenue, Broadway Avenue, and Jones Street to District 2.

Member Cooper, seconded by Member Pierce, moved that a boundary be set between Districts 2 and 3 on Van Ness Avenue, Broadway Avenue, Jones Street, Columbus Avenue, and Leavenworth Street to the bay waterfront. The motion failed by the following vote:

Member Castillion directed Q2 Data and Research to make further adjustments to the 4D map as follows:

- Add the East Cut neighborhood into District 6;
- Add the Tenderloin neighborhood north of Market Street into District 5;
- Add the Hub neighborhood into District 6; and
- Add the Dogpatch neighborhood into District 6, with a boundary at Islais Creek.

Upon return from recess Member Castillion directed Q2 Data and Research to make further adjustments to the 4D map as follows:

This change was not committed to the 4D map.


